3 SEC. 9. This Act is repealed effective June 30, ~~1996~~ 2000.

4 Sec. 2. This Act, being deemed of immediate importance,

6 EXPLANATION

7 This bill amends the section of the 1991 Iowa Acts which  
8 provides for the repeal of the prevention of disabilities  
9 chapter of the Code, chapter 225B, effective June 30, 1996, by  
10 extending the repeal date to June 30, 2000. The chapter  
11 includes establishment of the prevention of disabilities  
12 policy council and the technical assistance committee to the  
13 council.
