2 as follows:

3 326.45 ISSUANCE -- TITLE OBLIGATION.

4 Upon receiving application for and payment of the
5 registration fee ~~and notification of title~~, the department
6 shall issue registration identification to the applicant
7 carrier ~~and~~. Upon receiving application for and payment of
8 the title fee and notification of title, the department shall
9 send the certificate of title to the vehicle owner or
10 lienholder. The department shall adopt rules pursuant to
11 chapter 17A to process registration of vehicles titled in
12 other states.

13 EXPLANATION

14 This bill permits, for carriers subject to proportional
15 registration, issuance of registration identification to a
16 carrier upon payment of the registration fee without
