2 Code 1995, is amended to read as follows:

3 1. Two legislators members of the general assembly
4 appointed in a manner so that both chambers of the general
5 assembly and both major political parties are represented.
6 The senate appointment shall be made by the president of the
7 senate, and the house of representatives appointment shall be
8 made by the speaker of the house. The terms of legislative
9 members shall coincide with the term of the current general
10 assembly. Legislative members are eligible for per diem and
11 expenses as provided in section 2.10.

12 EXPLANATION

13 This bill relates to legislative appointments to the state
14 child day care advisory council in section 237A.21. Current
15 law provides for appointment of two legislators so that both
16 major political parties are represented. The bill specifies
17 that both chambers of the general assembly are to be

19 president of the senate and the speaker of the house. The
