Section 1. Section 422.45, Code Supplement 1995, is 2 amended by adding the following new subsection:

The gross receipts from the sale of 4 property which is a container, label, carton, pallet, packing 5 case, wrapping, baling wire, twine, bag, bottle, shipping 6 case, or other similar article or receptacle sold for use in 7 agricultural, livestock, or dairy production.

### EXPLANATION

#### AN ACT

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:
