1 Section 1. Section 22.7, Code Supplement 1995, is amended  
2 by adding the following new subsection:

15 EXPLANATION

16 This bill designates that social security numbers,  
17 collected and included in record systems maintained by the  
18 treasurer of state and the department of revenue and finance  
19 in the course of administering claims for unclaimed property  
20 and outdated warrants, shall be kept confidential under the  
21 public records law. The department of revenue and finance is  
22 directed by section 556.11 to administer claims for unclaimed  
23 property and outdated warrants.

Section 1. Section 22.7, Code Supplement 1995, is amended by adding the following new subsection:
