1 Section 1. Section 400.17, Code 1995, is amended by adding
2 the following new unnumbered paragraph:

3 NEW UNNUMBERED PARAGRAPH. A member of a bargaining unit
4 composed of fire department personnel of a city who is elected
5 or appointed as an officer of a statewide organization or
6 local association composed of fire department personnel shall
7 be granted leave by the city to perform duties required by the
8 organization or association without loss of pay or benefits
9 subject to the requirements of this paragraph. The member
10 shall not be required to work additional hours for time spent
11 performing duties required by the organization or association.
12 The member shall be required to notify the city of the
13 member's election or appointment as an officer in such an
14 organization or association and to arrange for a trade of work
15 time with another qualified fire department member.

16 Sec. 2. EFFECTIVE DATE. This Act, being deemed of
17 immediate importance, takes effect upon enactment.

18 EXPLANATION

19 This bill provides that a fire department member subject to
20 civil service shall be permitted to become an officer of a
21 statewide or local organization or association composed of
22 fire department personnel without loss of pay or benefits.
23 The bill requires the member to notify the city of the
24 member's election or appointment and to arrange with other
25 qualified fire department members to trade time to permit the
26 member to perform the duties of the member's office. The bill
27 prohibits a city from requiring the member to work additional
28 hours based on hours missed working for the organization or
29 association.

30 This bill takes effect upon enactment.
