1 Section 1. NEW SECTION. 321.447 RIDING ON MOTOR VEHICLE
2 PROHIBITED.

3 A person under the age of eighteen shall not ride and shall
4 not allow a person under the age of eighteen on a motor
5 vehicle or upon any portion of a motor vehicle not designed or
6 intended for use of passengers when the motor vehicle is in
7 motion. This section does not apply under any of the
8 following circumstances:

9 1. The motor vehicle is operated in a parade which is
10 officially authorized or otherwise permitted by law.

11 2. The motor vehicle is being operated for agricultural
12 purposes.

13 Sec. 2. Section 805.8, subsection 2, Code 1995, is amended
14 by adding the following new paragraph:

15 NEW PARAGRAPH. z. For riding on a motor vehicle or
16 allowing a person to ride on a motor vehicle in violation of
17 section 321.447, the scheduled fine is twenty-five dollars.

18 EXPLANATION

19 This bill creates new section 321.447 which prohibits a
20 person under the age of 18 from riding and prohibits an
21 operator from allowing a person under the age of 18 from
22 riding on any motor vehicle or upon any portion of a motor
23 vehicle not designed or intended for use of passengers when
24 the motor vehicle is in motion. The prohibition does not
25 apply to operation of a motor vehicle in a parade or while the
26 motor vehicle is being operated for agricultural purposes.

27 The scheduled fine for riding on or allowing a person to
28 ride on a motor vehicle in violation of section 312.447 is
29 \$25.
