- 1 Section 1. <u>NEW SECTION</u>. 514C.13 PROVIDERS OF HEALTH CARE 2 SERVICES -- CONTRACT -- PROHIBITION.
- 3 1. A contract between a provider of health care services
- 4 and an insurer shall not restrict the provider's discussions
- 5 with a covered individual and shall not prohibit a provider
- 6 from providing any information to a covered individual
- 7 relating to the contract between the insurer and the provider
- 8 or relating to the services or benefits to which a covered
- 9 individual may be entitled. Areas of discussion or provision
- 10 of information which shall not be restricted or prohibited
- 11 include, but are not limited to, treatment options, payment
- 12 policies, and terms and conditions of the contract between the
- 13 insurer and the provider. Additionally, the contract shall
- 14 not require that a provider support the insurer's philosophy
- 15 or concepts regarding the provision of health care services
- 16 and shall not prohibit the provider from expressing the
- 17 provider's opinion of the insurer. The commissioner of
- 18 insurance or director of public health shall apply appropriate
- 19 licensure sanctions to any insurer in violation of this
- 20 section.
- 21 2. For the purposes of this section:
- 22 a. "Health care services" means services included in the
- 23 furnishing to any individual of medical or dental care, or
- 24 hospitalization, or incident to the furnishing of such care or
- 25 hospitalization, as well as the furnishing to any person of
- 26 all other services for the purposes of preventing,
- 27 alleviating, curing, or healing human illness, injury, or
- 28 physical disability.
- 29 b. "Insurer" means a person who provides an individual or
- 30 group policy of accident or health insurance or individual or
- 31 group hospital or health care service contract issued pursuant
- 32 to chapter 509, 509A, 514, or 514A, an individual or group
- 33 health maintenance organization contract issued and regulated
- 34 under chapter 514B, an individual or group preferred provider
- 35 organization contract issued and regulated under chapter 514F,

1 or a contract of an individual or group organized delivery 2 system licensed by the director of public health under chapter 3 513C covering individuals for health care services. EXPLANATION This bill prohibits an insurer in the contract between the 6 provider of health care services and the insurer from 7 restricting discussions between the provider and a covered 8 individual and from prohibiting the provision of information 9 to a covered individual relating to the contract or relating 10 to the services or benefits to which a covered individual may 11 be entitled. Additionally, the bill prohibits the contract 12 from requiring a provider's support of the philosophy or 13 concepts of the insurer and prohibits the provider from 14 expressing the provider's opinion of the insurer.
