- Section 1. <u>NEW SECTION</u>. 136E.1 WARNINGS OF RISKS
- 2 ASSOCIATED WITH ALCOHOL.
- 3 1. A person in the course of doing business who holds a
- 4 license or permit under chapter 123 to sell alcoholic
- 5 beverages for consumption on the premises shall not knowingly
- 6 and intentionally expose another person to alcoholic beverages
- 7 which have been linked to birth defects without providing a
- 8 warning as prescribed by rule of the Iowa department of public
- 9 health.
- 10 2. The Iowa department of public health shall adopt rules
- 11 which require a warning regarding the risks associated with
- 12 the use of alcoholic beverages during pregnancy in the form of
- 13 a sign posted in the restrooms of the establishment.
- 3. A warning shall include the following language:
- 15 "WARNING: Drinking alcoholic beverages during pregnancy may
- 16 cause birth defects".
- 17 4. A person who does not provide a warning as prescribed
- 18 under this section is guilty of a simple misdemeanor.
- 19 EXPLANATION
- 20 This bill requires persons who hold a license or permit to
- 21 sell alcoholic beverages to post signs in the restrooms of the
- 22 establishment to provide warnings of the risks associated with
- 23 drinking alcohol during pregnancy. A person who does not
- 24 provide the warning is guilty of a simple misdemeanor.
