      This bill adds attempted murder to the list of crimes for
 7 which an inmate must serve 100 percent of their sentence less
 8 any of the limited amount of good time which may be granted to
 9 the inmate. Under section 903A.2, inmates sentenced under
10 section 902.12 may only receive reductions in sentence for
11 good behavior in an amount not to exceed 15 percent of the
12 sentence imposed--meaning that the inmate must effectively
13 serve at least 85 percent of the sentence imposed.
      Attempted murder is a class "B" felony. Class "B" felons

## HOUSE FILE 2002 FISCAL NOTE

The estimate for House File 2002 is hereby submitted as a fiscal note pursuant to Joint Rule 17 and as a correctional impact statement pursuant to Section 2.56, Code of Iowa. Data used in developing this fiscal note and correctional impact statement are available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 2002 adds attempted murder to the list of crimes for which the offender is required to serve 100.0% of the sentence with a maximum reduction of 15.0% for good time.

### BACKCROUND

Attempted murder is a Class B Felony and carries a maximum sentence of 25 years.

## **ASSUMPTIONS**

- 1. Charge, conviction, and sentencing patterns will remain constant over the projection period.
- Prisoner length of stay, revocation rates, and other correctional system
  policies and practices will remain constant over the projection period,
  except for penalty under examination.
- 3. There is a lag effect of one year from the law's effective date for the first offender's entry into the prison system.
- 4. Eleven offenders will be incarcerated annually for attempted murder under the enhanced penalty.
- 5. The current average sentence for attempted murder is 103 months (8.6 years).
- 6. The projected length of stay will be 255 months (85.0% of 25 years or 21.3 years).
- 7. The average cost per day for inmate support is \$12.
- Costs are stated in FY 1999 dollars.

#### CORRECTIONAL IMPACT

This Bill will have no short-term effect on the correctional system. In the long-term, this Bill will add 70 inmates to the prison system during the first ten years after implementation (FY 2008) and will add another 110 inmates during the next ten year period (FY 2018).

#### **FISCAL IMPACT**

This Bill will create no additional costs in the short-term. This Bill is projected to increase the annual cost for inmate support by an additional \$307,000 over the first ten years after implementation (PY 2008). By twenty years after implementation (FY 2018), the annual inmate support costs are projected to have increased to an additional \$788,000.
