A BILL FOR 1 An Act relating to the maximum number of nonresident deer hunting licenses and nonresident wild turkey hunting licenses which may be issued annually. 4 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

- 1 Section 1. Section 483A.7, subsection 3, Code 1997, is 2 amended to read as follows:
- 3 3. A nonresident wild turkey hunter is required to have
- 4 only a nonresident wild turkey hunting license and a wildlife
- 5 habitat stamp. The commission shall annually limit to two
- 6 four thousand licenses the number of nonresidents allowed to
- 7 have wild turkey hunting licenses. The number of nonresident
- 8 wild turkey hunting licenses shall be determined as provided
- 9 in section 481A.38. The commission shall allocate the
- 10 nonresident wild turkey hunting licenses issued among the
- 11 zones based on the populations of wild turkey. A nonresident
- 12 applying for a wild turkey hunting license must exhibit proof

- 22 the number of nonresidents allowed to have deer hunting
- 23 licenses. The number of nonresident deer hunting licenses

EXPLANATION This bill increases the number of nonresident wild turkey 3 hunting licenses which may be issued annually from 2,000 to 4 4,000, and the number of nonresident deer hunting licenses 5 which may be issued annually from 5,000 to 10,000.

HOUSE FILE 2013 FISCAL NOTE

A fiscal note for House File 2013 is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 2013 increases the number of hunting permits sold to nonresident hunters for wild turkey and deer.

BACKGROUND

To encourage nonresident hunting in Iowa, House File 2013 increases the number of nonresident wild turkey licenses sold from 2,000 to 4,000 and increases the number of nonresident deer licenses from 5,000 to 10,000. The hunter must exhibit proof of having completed a hunter safety and ethics education program or its equivalent before the license is issued.

ASSUMPTIONS

The cost of a wild turkey license is \$55 and \$110 for a deer license. In 1997, there were 2,312 applications for nonresident wild turkey licenses and 6,642 applications for nonresident deer licenses.

FISCAL IMPACT

The estimated fiscal impact of House File 2013 would be an increase of \$110,000 in revenue from the sale of nonresident wild turkey licenses and \$550,000 from the sales of nonresident deer licenses if all of the available licenses are sold. However, based on the applications received in 1997, the increase would be \$17,160 for nonresident wild turkey licenses and \$180,620 for nonresident deer licenses.
