      Section 1. Section 295.4, subsection 1, Code 1997, is
 2 amended to read as follows:
      1. School districts, as defined in section 295.2,
 4 subsection 8, shall expend funds received pursuant to section
 5 295.2 for the acquisition, lease, lease-purchase,
 6 installation, and maintenance of instructional technology
 7 equipment, including hardware and software, materials and
 8 supplies related to instructional technology, and staff
 9 development and training related to instructional technology,
10 and shall establish priorities for the use of the funds.
11 Howevery-Eunds Funds received by a school district pursuant to
12 section 295.2 shall not be expended to add a full-time
13 equivalent position or otherwise increase staffing, unless the
14 position added is that of computer systems analyst.

      This bill permits school districts to employ computer
17 technicians using funds received under the school improvement
18 technology program.
19
      Currently, the Code prohibits the expenditure of program
20 funds to add a full-time equivalent position or otherwise
21 increase staffing. Program funds can currently be used by a
22 school district only for the acquisition, lease, lease-
23 purchase, installation, and maintenance of instructional
24 technology equipment, including hardware and software,
25 materials and supplies related to instructional technology,
26 and staff development and training related to instructional
27 technology.
