2 permittees.

1 Section 1. Section 123.124, Code 1997, is amended to read
2 as follows:

3 123.124 PERMITS -- CLASSES.

4 Permits for the manufacture and sale, or sale of beer shall
5 be divided into four classes, known as class "A", special
6 class "A", class "B", or class "C" permits. A class "A"
7 permit allows the holder to manufacture and sell beer at
8 wholesale. A holder of a special class "A" permit may only
9 manufacture beer to be consumed on ~~the licensed~~ a premises for
10 which the ~~person-also~~ holder holds a class "C" liquor control
11 license or class "B" beer permit and to be sold to a class "A"
12 permittee for resale purposes. A class "B" permit allows the
13 holder to sell beer to consumers at retail for consumption on
14 or off the premises. A class "C" permit allows the holder to
15 sell beer to consumers at retail for consumption off the
16 premises.

17 Sec. 2. Section 123.130, unnumbered paragraph 3, Code
18 1997, is amended to read as follows:

19 A person who holds a special class "A" permit ~~for the same~~
20 ~~location at which the person holds a class "C" liquor control~~
21 ~~license or class "B" beer permit~~ may manufacture and sell beer
22 to be consumed on the any premises for which the person holds
23 a class "C" liquor control license or a class "B" beer permit
24 and may sell beer to a class "A" permittee for resale
25 purposes.

26 Sec. 3. Section 123.136, unnumbered paragraph 1, Code
27 1997, is amended to read as follows:

28 In addition to the annual permit fee to be paid by all
29 class "A" permittees under this chapter there shall be levied
30 and collected from the permittees on all beer manufactured for
31 sale or sold in this state at wholesale and on all beer
32 imported into this state for sale at wholesale and sold in
33 this state at wholesale, and from special class "A" permittees
34 on all beer manufactured for consumption on ~~the~~ a premises
35 licensed or permitted pursuant to this chapter, a tax of five

1 and eighty-nine hundredths dollars for every barrel containing
2 thirty-one gallons, and at a like rate for any other quantity
3 or for the fractional part of a barrel. However, no tax shall
4 be levied or collected on beer shipped outside this state by a
5 class "A" permittee or sold by one class "A" permittee to
6 another class "A" permittee.

7 EXPLANATION

8 This bill authorizes a special class "A" beer permittee to
9 sell beer manufactured by the permittee at other premises
10 licensed or permitted for the sale of beer and operated by the
11 special class "A" beer permittee.
