RELATING TO THE EXEMPTION OF CERTAIN MULTIPLE EMPLOYER WELFARE ARRANGEMENTS FROM REGULATION BY THE INSURANCE DIVISION AND PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:
