1 Section 1. Section 368.7, subsection 2, Code 1997, is
2 amended to read as follows:

3 2. An application for annexation of territory not within
4 an urbanized area of a city other than the city to which the
5 annexation is directed must be approved by resolution of the
6 council which receives the application. Notice of the
7 application shall be published in an official county newspaper
8 in each county which contains a portion of the territory at
9 least ten days before any action is taken by the city council
10 on the application. In the discretion of a city council, the
11 resolution may include a provision for a transition for the
12 imposition of taxes as provided in section 368.11, subsection
13 13. Upon receiving approval of the council, the city clerk
14 shall file a copy of the resolution, map, and legal
15 description of the territory involved with the secretary of
16 state, county board of supervisors, each affected public
17 utility, and the state department of transportation. The city
18 clerk shall also record a copy of the legal description, map,
19 and resolution with the county recorder. The secretary of
20 state shall not accept and acknowledge a copy of a legal
21 description, map, and resolution of annexation which would
22 create an island. The annexation is completed upon
23 acknowledgment by the secretary of state that the secretary of
24 state has received the legal description, map, and resolution.

25 EXPLANATION

26 This bill provides that an application for annexation of
27 territory not within an urbanized area of a city other than
28 the city to which the annexation is directed shall not be
29 approved by the city council without notice of the application
30 being published in an official county newspaper in each county
31 which contains a portion of the territory at least 10 days
32 before any action is taken on the application.
