1 Section 1. Section 17A.8, subsections 4 and 5, Code 1997,  
2 are amended to read as follows:

3 4. The committee shall ~~choose a chairperson from its~~  
4 membership and be headed by two cochairpersons. The members  
5 of the committee from each house shall elect a chairperson  
6 from that house. The committee shall prescribe its rules of  
7 procedure. The committee may employ a secretary or may  
8 appoint the administrative code editor or a designee to act as  
9 secretary.

10 5. A regular committee meeting shall be held at the seat  
11 of government on the second Tuesday of each month. Unless  
12 impracticable, in advance of each such meeting the subject  
13 matter to be considered shall be published in the Iowa  
14 administrative bulletin. A special committee meeting may be
