Section 1. Section 99B.7, subsection 1, paragraph d, Code 1 2 1997, is amended to read as follows: d. Cash prizes shall not be awarded in games other than 4 bingo and raffles. The value of a prize shall not exceed two 5 hundred one thousand dollars and merchandise prizes shall not 6 be repurchased. If a prize consists of more than one item, 7 unit, or part, the aggregate value of all items, units, or 8 parts shall not exceed two-hundred one thousand dollars. 9 However, on? raffle may be conducted per calendar year at 10 which prizes having a combined value of more than two-hundred ll one thousand dollars may be awarded. If the prize is 12 merchandise, its value shall be determined by purchase price 13 paid by the organization or donor. 14 Section 99B.7, subsection 1, paragraph q, 15 unnumbered paragraph 1, Code 1997, is amended to read as 16 follows: 17 A licensee under this section may hold one real property 18 raffle per calendar year at which the value of the real 19 property may exceed two-hundred one thousand dollars in lieu 20 of the annual raffle authorized in subsection 1, paragraph 21 "d", if all of the following requirements are met: 22 **EXPLANATION** This bill increases the maximum value of a prize which may 23 24 be awarded in a raffle or game of skill or chance except 25 bingo. ## AN ACT

RELATING TO THE MAXIMUM VALUE OF PRIZES AWARDED IN RAFFLES AND CERTAIN GAMES OF SKILL AND CHANCE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 99B.7, subsection 1, paragraph d, Code 1997, is amended to read as follows:

- d. Cash prizes shall not be awarded in games other than bingo and raffles. The value of a prize shall not exceed two hundred one thousand dollars and merchandise prizes shall not be repurchased. If a prize consists of more than one item, unit, or part, the aggregate value of all items, units, or parts shall not exceed two-hundred one thousand dollars. However, one raffle may be conducted per calendar year at which prizes having a combined value of more than two-hundred one thousand dollars may be awarded. If the prize is merchandise, its value shall be determined by purchase price paid by the organization or donor.
- Sec. 2. Section 99B.7, subsection 1, paragraph q, unnumbered paragraph 1, Code 1997, is amended to read as follows:

A licensee under this section may hold one real property raffle per calendar year at which the value of the real property may exceed two-hundred one thousand dollars in lieu
