Section 1. Section 2.32, subsection 6, unnumbered
 paragraph 1, Code 1997, is amended to read as follows:
 The confirmation of every appointment submitted to the
 senate requires the approval of two-thirds a majority of the
 all members of elected to the senate.

6 Sec. 2. Section 2.32, subsection 8, Code 1997, is amended7 by striking the subsection.

8 Sec. 3. Section 333A.2, subsection 1, paragraph b, Code9 1997, is amended to read as follows:

b. Five elected county officials who are regularly involved in budget preparation. One county official shall be from a county with a population of less than eleven thousand five hundred, one from a county with a population of more than eleven thousand five hundred but not more than sixteen thousand, one from a county with a population of more than sixteen thousand but not more than twenty-two thousand five hundred, one from a county with a population of more than twenty-two thousand five hundred but not more than eighty thousand and one from a county with a population of more than eighty thousand. The governor shall select and appoint the county officials, subject to the-approval-of-two-thirds-of-the members-of confirmation by the senate.

23 Sec. 4. Section 333A.2, subsection 1, paragraph c, Code 24 1997, is amended to read as follows:

c. A certified public accountant experienced in governmental accounting selected and appointed by the governor with-the-approval-of-two-thirds-of-the-members-of, subject to confirmation by the senate.

29 Sec. 5. Section 80.3, Code 1997, is repealed.
30 EXPLANATION

31 This bill provides for modifications to the senate 32 confirmation process for gubernatorial appointments.

33 Code section 2.32, subsection 6, states that approval of 34 appointments submitted to the senate requires a two-thirds 35 favorable vote. This bill reduces the required number of

1 votes for approval to a majority vote of all members elected 2 to the senate. Code section 2.32, subsection 8, requires that 3 previously approved gubernatorial appointees are subject to 4 reconfirmation by the senate every four years, with the same 5 confirmation procedures applicable as with an initial 6 appointment. This bill repeals this subsection.

7 The bill also repeals or modifies the inconsistent 8 provisions of Code section 80.3, relating to appointments to 9 fill vacancies in the position of commissioner of public 10 safety, and Code section 333A.2, relating to county finance 11 committee membership, to promote consistency with Code section 12 2.32 modifications.
