1 An Act relating to the registration fee for ex-prisoner of war 2 motor vehicle plates and providing effective and retroactive 3 applicability dates.

Section 1. Section 321.34, Code 1997, is amended by adding 2 the following new subsection:
3 NEW SUBSECTION. 8A. EX-PRISONER OF WAR SPECIAL PLATES. 4 The owner of a motor vehicle subject to registration under

5 section 321.109 , subsection 1, light delivery truck, panel
6 delivery truck, or pickup who was a prisoner of war during the
7 Second World War at any time between December 7, 1941, and
8 December 31, 1946 , the Korean Conflict at any time between
9 June 25, 1950, and January 31, 1955, or the Vietnam Conflict
10 at any time between August 5, 1964, and June 30, 1973, all
11 dates inclusive, may, upon written application to the
12 department, order special registration plates with an ex13 prisoner of war processed emblem with the emblem designed by 14 the department in cooperation with the adjutant general which 15 emblem signifies that the owner was a prisoner of war as 16 described in this subsection. The application is subject to 17 approval by the department, in consultation with the adjutant 18 general. The special plates are subject to an annual fee of 19 fifteen dollars. The department shall validate the special 20 plates in the same manner as regular registration plates are 21 validated under this section.

4 This bill provides that the fee for ex-prisoner of war 5 special motor vehicle registration plates is only $\$ 15$ and does 6 not include the regular annual registration fee and provides
7 that the department of transportation is to validate the 8 plates in the same manner as regular plates.
9 The bill takes effect upon enactment and is retroactively 10 effective to January 1,1997 . The bill requires county

1 Amend House File 31 as follows:

1. Page 1 , line 12 , by inserting after the word "order" the following: "only one set of".
2. Page 1 , line 13 , by striking the words "emblem with the emblem" and inserting the following: "emblem. The emblem shall be".
3. Page 1 , lines 14 and 15 , by striking the words "which emblem signifies" and inserting the following: "and shall signify".
4. Page 1 , line 18, by inserting after the word "plates" the following: "shall be issued at no charge and".
5. Page 1 , line 19 , by striking the word "department" and inserting the following: "county treasurer".
6. Page 1 , by inserting after line 31 , the following:
"Sec. $\qquad$ . A person eligible to be issued exprisoner of war special plates who ordered and paid for the special plates on or after January 1,1997 , but prior to the effective date of this Act shall be entitled to a refund from the state department of transportation of all fees in excess of fifteen dollars paid for issuance of one set of the special plates. A person eligible for a refund under this section shall submit a claim for a refund to the state department of transportation on a form for that purpose obtained from the county treasurer. Notwithstanding any provision of the code to the contrary, refunds shall be paid by the department from registration fees deposited in the road use tax fund under section 321.145 .

A person who obtained more than one set of special plates under section 321.34 , subsection 15 , shall surrender the additional set or sets of special plates not later than the end of the registration year for which the plates were issued. A refund shall not be issued for additional sets of special plates."
7. By striking page 1, line 34 , through page 2, line 2, and inserting the following: "and is retroactively applicable to January 1, 1997."
8. By renumbering as necessary.
