HOUSE FILE 368 FISCAL NOTE

A fiscal note for **House File 368** is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 368 requires the Department of Economic Development (DED) to establish an Entrepreneurial Ventures Assistance Program within the Strategic Investment Fund. The Program would provide early stage technical (up to \$5,000) and financial (up to \$20,000) assistance to entrepreneurial projects after the principal participants in the project have successfully completed a recognized venture capital curriculum.

FISCAL IMPACT

The DED estimates approximately 23 projects in FY 1998 and 40 in FY 1999 will receive funding through the Program. Total funding required would be \$350,000 in FY 1998 and \$510,000 in FY 1999. The Economic Development Appropriations Bill, as passed by the House Appropriations Committee, allows the DED to expend up to \$600,000 on the Program in FY 1998. That Bill also provides \$369,000 in new funding to the Strategic Investment Fund to finance the new Program.

Entrepreneurial Ventures Assistance Program (EVA)

Over the past ten years, Iowa has ranked at or near the bottom among states in the capacity to generate new businesses. The reasons for Iowa's lagging performance are many, including the inability to develop close relationships between young entrepreneurs and tenured business mentors, as well as the lack of networking between these businesses and the financial industry.

The EVA program will make these essential tools available to businesses and work to place Iowa into the upper half of the states when measuring rates of new business formation. It will coordinate activity with the recently announced John Pappajohn entrepreneurial initiative to assist new business development, market expansion, and communications technology modernization projects for early-stage targeted industry, agriculture, and value-added manufacturing and services in Iowa. Initial efforts will concentrate on assisting managerial personnel to develop the necessary entrepreneurial skill levels. Ultimately, the technical and financial assistance offered will contribute towards creating an environment for maximum business success.

The Iowa Department of Economic Development (IDED) will work with educational organizations and private sector partners to plan and deliver the program. For example, EVA will create a statewide integration of the John Pappajohn Entrepreneurial Centers, or similar 'entrepreneurial colleges,' with IDED small business development activities.

AN ACT

RELATING TO THE ESTABLISHMENT OF THE ENTREPRENEURIAL VEN-TURES ASSISTANCE PROGRAM AND ALLOCATING FUNDS FROM THE IOWA STRATEGIC INVESTMENT FUND FOR THE ADMINISTRATION AND OPERATION OF THE PROGRAM.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. <u>NEW SECTION</u>. 15.338 SHORT TITLE.

This part shall be known and may be cited as the "Entrepreneurial Ventures Assistance Program".

Sec. 2. <u>NEW SECTION</u>. 15.339 ENTREPRENEURIAL VENTURES ASSISTANCE.

- 1. As used in this section, unless the context otherwise requires, "early-stage industry company" means a company with three years or less of experience in a particular industry.
- 2. The department shall establish a program to provide financial and technical assistance to early-stage industry companies and entrepreneurs. The purpose of the program is to encourage the development of entrepreneurial venture planning and managerial skills in conjunction with the delivery of a financial assistance program for business start-ups and expansions. An applicant eligible for the program includes an individual who is participating in or has successfully completed a recognized entrepreneurial venture development curriculum, or a business whose principal participants have successfully completed a recognized entrepreneurial venture development curriculum.
- 3. Each application for financial assistance submitted to the department must include a business plan, a marketing plan, a budget, and a statement of purpose stating how the financial assistance will be used.
- Unless otherwise authorized by the director, the department shall not provide more than five thousand dollars

of technical assistance per project, and shall not provide more than a total of twenty thousand dollars in financial assistance per project.

- 5. In addition to funds appropriated for the program, the department may allocate resources from the Iowa strategic investment fund under section 15.313 for the administration and operation of the program.
- 6. The department shall adopt administrative rules pursuant to chapter 17A to administer this section.
