

An Act providing distance requirements for animal feeding
operation structures and making penalties applicable.
BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 455B.171, Code 1997, is amended by 2 adding the following new subsection:

3 <u>NEW SUBSECTION</u>. 2A. "Animal feeding operation structure" 4 means the same as defined in section 455B.161.

5 Sec. 2. Section 455B.204, subsection 1, unnumbered 6 paragraph 1, Code 1997, is amended to read as follows:

7 An animal feeding operation structure shall <u>not</u> be located 8 at-least <u>constructed or expanded less than</u> five hundred feet 9 away from the surface intake of an agricultural drainage well 10 or known sinkhole, and at-least-two <u>not less than five</u> hundred 11 feet away from a lake, river, or stream located within the 12 territorial limits of the state, any marginal river area 13 adjacent to the state, which can support a floating vessel 14 capable of carrying one or more persons during a total of a 15 six-month period in one out of ten years, excluding periods of 16 flooding. However, no distance separation is required between 17 a location or object and a farm pond or privately owned lake, 18 as defined in section 462A.2.

EXPLANATION

This bill amends Code section 455B.204 which in part provides distance requirements between an animal feeding operation structure and a lake, river, or stream located within the territorial limits of the state, or any marginal river area adjacent to the state. This bill increases the distance requirement from 200 to 500 feet and applies the requirement to newly constructed or expanded animal feeding structures. A person violating the bill is subject to a civil penalty of not more than \$5,000.
