1 Section 1. NEW SECTION. 322.36 MOTORCYCLE DEALER
2 BUSINESS HOURS.

3 A person in the business of selling motorcycles under
4 chapter 322D is not required to maintain regular business
5 hours at the dealer's principal place of business or other
6 place of business.

7 EXPLANATION

8 This bill provides that a motorcycle dealer is not required
9 to maintain regular business hours at the dealer's principal
10 place of business or other business locations. Currently, 761
11 IAC 425.3 requires that such dealers be consistently open to
12 the public for a minimum of 32 posted hours each week between
13 Monday and Friday, inclusive.
