The agent must certify to the secretary 13 of state that the copy has been sent to the limited 14 partnership. The termination is effective on the date the 15 statement is filed by the secretary of state. Currently, the 16 agent must file a written notice of resignation in duplicate 17 with the secretary of state and the secretary of state must 18 send a copy of the resignation to the limited partnership. Code section 487.104A is amended by striking the 19 20 requirement that a limited partnership include the name and 21 address of the limited partnership's current registered office 22 and registered agent in a statement filed with the secretary 23 of state changing the limited partnership's registered office 24 or registered agent.

25 Code section 487.902 is amended to provide that the 26 secretary of state is the agent of a foreign limited 27 partnership for service of process if the registered agent has 28 resigned and an agent has not been appointed. If the secretary of 2 state determines that an annual report does not contain the 3 information required by section 504A.83 but otherwise meets 4 the requirements of this section for the purpose of changing 5 the registered office or registered agent, the secretary of 6 state shall file the statement of change of registered office 7 or registered agent before returning the annual report to the 8 corporation pursuant to section 504A.84. A statement of 9 change of registered office or registered agent pursuant to 10 this paragraph shall be executed by a person authorized to 11 execute the annual report.

13 This bill amends provisions relating to the appointment and 14 resignation of registered agents of corporations and 15 partnerships.

EXPLANATION

16 Code section 487.104 is amended to provide that an agent 17 for service of process may resign by delivering a signed 18 original statement of resignation to the secretary of state 19 and sending a copy of the resignation by certified mail to the 20 limited partnership. The agent must certify to the secretary 21 of state that the copy has been sent to the limited 22 partnership. The termination is effective on the date the 23 statement is filed by the secretary of state. Currently, the 24 agent must file a written notice of resignation in duplicate 25 with the secretary of state and the secretary of state must 26 send a copy of the resignation to the limited partnership. 27 Code section 487.104A is amended by striking the 28 requirement that a limited partnership include the name and 29 address of the limited partnership's current registered office 30 and registered agent in a statement filed with the secretary 31 of state changing the limited partnership's registered office 32 or registered agent.

33 Code section 487.902 is amended to provide that the 34 secretary of state is the agent of a foreign limited 35 partnership for service of process if the registered agent has

1 resigned and an agent has not been appointed. Currently, the 2 section provides that the secretary of state is the agent of a 3 foreign limited partnership for service of process if an agent 4 has not been appointed pursuant to the section. However, 5 prior to transacting business in this state, an agent must be 6 appointed.

7 Code section 487.909 is amended to provide that an agent 8 for service of process may resign by delivering a signed 9 original statement of resignation to the secretary of state 10 and sending a copy of the resignation by certified mail to the 11 foreign limited partnership. The agent must certify to the 12 secretary of state that the copy has been sent to the foreign 13 limited partnership. The termination is effective on the date 14 the statement is filed by the secretary of state. Currently, 15 the agent must file a written notice of resignation in 16 duplicate with the secretary of state and the secretary of 17 state must send a copy of the resignation to the foreign 18 limited partnership.

New Code section 487.911 is created and establishes the 19 20 requirements for a foreign limited partnership to change its 21 registered office or registered agent. The requirements are 22 similar to the requirements established in Code section 23 487.104A which apply to domestic limited partnerships. Code section 490.1701 is amended to provide that a 24 25 corporation which is not subject to chapter 490, but which 26 voluntarily elects to adopt the provisions of chapter 490, is 27 to forward a copy of the instrument providing for such 28 election to the county recorder of the county in which the 29 corporation's principal place of business is located. The 30 corporation must also forward a copy of the original 31 instrument and a copy of the corporation's articles of 32 incorporation to the county recorder of the county in which 33 the initial registered office of the corporation is located. 34 Currently the secretary of state is required to forward these 35 documents. The corporation must certify to the secretary of

1 state through an officer or director that such copies have
2 been sent.

Code section 504A.9 is amended by striking the requirement 3 4 that a nonprofit corporation include the name and address of 5 the corporation's current registered office and registered 6 agent in a statement filed with the secretary of state 7 changing the corporation's registered office or registered 8 agent. The section is also amended to provide that an agent 9 for service of process may resign by delivering a signed 10 original statement of resignation to the secretary of state 11 and sending a copy of the resignation by certified mail to the 12 corporation. The agent must certify to the secretary of state 13 that the copy has been sent to the corporation. The 14 termination is effective on the date the statement is filed 15 with the secretary of state. The statement may also contain a 16 statement that the registered office is also discontinued. 17 Currently, the agent must file a written notice of resignation 18 in duplicate with the secretary of state and the secretary of 19 state must send a copy of the resignation to the corporation. 20

RELATING TO THE APPOINTMENT AND RESIGNATION OF REGISTERED AGENTS OF CORPORATIONS, LIMITED LIABILITY COMPANIES, AND PARTNERSHIPS AND THEIR REGISTERED OPFICES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 487.104, subsection 3, Code 1997, is amended to read as follows:

3. An agent for service of process may resign as agent upon by signing and delivering to the secretary of state an original statement of resignation for filing and-recording in accordance with section 487.206 a-written-notice-of resignation;-executed-in-duplicate;-with-the-secretary-of state. The secretary-of-state-shall-forthwith-mail agent shall send a copy of the statement of resignation by certified mail to the limited partnership at its principal place of business. The agent shall certify to the secretary of state that the copy has been sent to the limited partnership, including the date the copy was sent. The appointment of the agent terminates upon the-expiration-of-thirty-days-after receipt-of-the-notice-by on the date on which the statement is filed by the secretary of state.

Sec. 2. Section 487.104A, subsection 1, paragraphs b and d, Code 1997, are amended by striking the paragraphs.

Sec. 3. Section 487.902, subsection 5, Code 1997, is amended to read as follows:

5. A statement that the secretary of state is the agent of the foreign limited partnership for service of process if <u>the</u> <u>registered agent has resigned and</u> an agent has not been appointed under subsection 4 or, if appointed, the agent's authority has been revoked, or if the agent cannot be found or served with the exercise of reasonable diligence. Sec. 4. Section 487.909, Code 1997, is amended to read as follows:

487.909 RESIGNATION OF AGENT FOR SERVICE OF PROCESS. An agent for service of process of a foreign limited partnership may resign as agent upon-filing-n-written-notice of-the-resignation, executed-in-duplicate, with-the-secretary of state by signing and delivering to the secretary of state an original statement of resignation for filing in accordance with section 487.206. The secretory-of-state agent shall forthwith-mail send a copy of the statement of resignation by certified mail to the foreign limited partnership at its principal office-or-office-required-to-be-maintained-in-the state-of-its-organization place of business. The agent shall certify to the secretary of state that the copy has been sent to the limited partnership, including the date the copy was sent. The appointment of the agent terminates upon-the expiration-of-thirty-days-after-receipt-of-the-notice-by on the date on which the statement is filed by the secretary of state.

Sec. 5. <u>New Section</u>. 487.911 CHANGE OF REGISTERED OFFICE OR REGISTERED AGENT.

 A foreign limited partnership may change its registered office or registered agent by delivering to the secretary of state for filing a statement of change that sets forth all of the following:

a. The name of the foreign limited partnership.

b. If the current registered office is to be changed, the street address of the new registered office.

c. If the current registered agent is to be changed, the name of the new registered agent and the new agent's written consent to the appointment, either on the statement or attached to the statement.

d. That after the change or changes are made, the street addresses of its registered office and the business office of its registered agent will be identical.

2. If a registered agent changes the street address of the registered agent's business office, the registered agent may change the street address of the registered office of any foreign limited partnership for which the person is the registered agent by notifying the foreign limited partnership in writing of the change and signing, either manually or in facsimile, and delivering to the secretary of state for filing a statement that complies with the reguirements of subsection 1 and recites that the foreign limited partnership has been notified of the change.

3. If a registered agent changes the registered agent's business address to another place, the registered agent may change the business address and the address of the registered agent by filing a statement as required in subsection 2 for each foreign limited partnership, or a single statement for all foreign limited partnerships named in the notice, except that the statement need be signed only by the registered agent or agents and need not be responsive to subsection 1, paragraph "c", and must recite that a copy of the statement has been mailed to each foreign limited partnership named in the notice.

4. A document delivered to the secretary of state for the purpose of changing a foreign limited partnership's registered agent or registered office may be executed by a general partner.

Sec. 6. Section 490.1701, subsection 3, paragraph c, unnumbered paragraph 2, Code 1997, is amended to read as follows:

If the county of the initial registered office as stated in the instrument is one which is other than the county where the principal place of business of the corporation, as designated in its articles of incorporation, was located, the secretary of-state corporation shall forward also to the county recorder of the county in which the principal place of business of the corporation was located a copy of the instrument and the secretary-of-state corporation shall forward to the recorder of the county in which the initial registered office of the corporation is located, in addition to <u>a copy of</u> the original of-the instrument, a copy of the articles of incorporation of the corporation together with all amendments to them as then on file in the secretary of state's office. The corporation shall, through an officer or director, certify to the secretary of state that a copy has been sent to each applicable county recorder, including the date each copy was sent.

Sec. 7. Section 490A.502, subsection 1, paragraphs b and d, Code 1997, are amended by striking the paragraphs.

Sec. 8. Section 490A.502, Code 1997, is amended by adding the following new subsection:

NEW SUBSECTION. 4. The change of address of a registered office or the change of registered agent becomes effective upon the filing of such statement by the secretary of state.

Sec. 9. Section 490A.503, Code 1997, is amended to read as follows:

490A.503 RESIGNATION OF REGISTERED AGENT.

1. A registered agent may resign the agent's agency appointment by signing and delivering to the secretary of state for filing the-signed an original and-two-exact-copies or-conformed-copies-of-a statement of resignation. The statement may include a statement that the registered office is also discontinued. After-filing-the-statement-the secretary-of-state The registered agent shall mail-one send a copy of the statement of resignation to the registered office. if not discontinued, and the-other-copy to the limited liability company at its principal office. The agent shall certify to the secretary of state that the copy has been sent to the limited liability company, including the date the copy Was gent.

2. The agency appointment is terminated, and the registered office discontinued if so provided, on the thirty-

for all corporations named therein in the statement, except that it the statement need be signed only by the registered agent or agents and need not be responsive to subsection 5 above 1, paragraph "c", and but must recite that notification of such change has been mailed to each such corporation named in the statement.

4. The change of address of registered office or the change of registered agent or-agents-or-both-registered-office and-agent-or-agents-case-may-bez-shall-become becomes effective upon the filing of such statement by the secretary of state.

Any A registered agent of a corporation may resign as such agent upon by signing and delivering to the secretary of state for filing a-written-notice-thereofy-executed-in duplicater-with-the-secretary-of-stater-who-shall-record-one copy-and-forthwith-mail-the-other-copy-thereof-to-the corporation-in-care-of-an-officery-who-is-not-the-resigning registered-agenty-at-the-address-of-such-officer-as-shown-by the-most-recent-annual-report-of-the-corporation an original statement of resignation. The statement of resignation may also include a statement that the registered office is also discontinued. The registered agent shall send a copy of the statement of resignation by certified mail to the corporation at its principal office and to the registered office, if the registered office is not discontinued. The appointment of such the agent shall terminate-upon-the-expiration-of-thirty deys-after-receipt-of-such-notice-by terminates on the date on which the statement is filed by the secretary of state. If the statement of resignation contains a statement that the registered office is discontinued, such office is discontinued on the date on which the statement of resignation is filed by the secretary of state.
