1 Section 1. Section 566A.5, subsection 1, Code 1997, is  
2 amended by striking the subsection.

3 Sec. 2. Section 566A.5, subsection 2, Code 1997, is  
4 amended to read as follows:

5 ~~2.~~ 1. Each nonperpetual care cemetery shall ~~also~~ have  
6 printed or stamped at the head of all of its contracts, deeds,  
7 statements, letterheads, and advertising material, the legend:  
8 "This is a nonperpetual care cemetery", and shall not sell any  
9 lot or interment space in the cemetery unless the purchaser of  
10 the lot or interment space is informed that the cemetery is a  
11 nonperpetual care cemetery.

12 EXPLANATION

13 This bill strikes the requirement that a nonperpetual care  
14 cemetery post a legible sign in a conspicuous place indicating  
15 the cemetery is not a perpetual care cemetery. The cemetery  
16 would still be required to have printed or stamped at the head  
17 of all of its contracts, deeds, statements, letterheads, and  
18 advertising material that the cemetery is a nonperpetual care  
19 cemetery.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 566A.5, subsection 1, Code 1997, is amended by striking the subsection.


Sec. 2. Section 566A.5, subsection 2, Code 1997, is amended to read as follows:

2. 1. Each nonperpetual care cemetery shall ~~also~~ have printed or stamped at the head of all of its contracts, deeds, statements, letterheads, and advertising material, the legend: "This is a nonperpetual care cemetery", and shall not sell any lot or interment space in the cemetery unless the purchaser of
