1 Section 1. DEPARTMENT OF EDUCATION. There is appropriated  
2 from the general fund of the state to the department of  
3 education for the fiscal year beginning July 1, 1998, and  
4 ending June 30, 1999, the following amount, or so much thereof  
5 as may be necessary, to be used for the purpose designated:

6 COMMUNITY COLLEGES

7 For staff development for licensed professional staff at  
8 the community colleges:

27 EXPLANATION

28 This bill appropriates \$2 million to the department of  
29 education for staff development for licensed professional  
30 staff at the community colleges. The bill provides for the  
31 allocation of the moneys based upon the formula used to  
32 distribute general state financial aid to the community  
33 colleges.
