1 Section 1. Section 331.655, subsection 1, paragraphs h and  
2 k, Code 1997, are amended to read as follows:

3 h. For the time necessarily employed in making an  
4 inventory of personal property attached or levied upon, ~~eight~~  
5 dollars-per-hour compensation determined by the board of  
6 supervisors.

7 k. For attending sale of property, ~~thirty-dollars~~  
8 compensation determined by the board of supervisors.

9 Sec. 2. Section 25B.2, subsection 3, shall not apply to  
10 this Act.

11 EXPLANATION

12 This bill provides that the board of supervisors determines  
13 the compensation received by the sheriff for inventorying and  
14 attending sales of property. Under current law, the sheriff  
15 is paid a fee of \$8 per hour for the inventory of personal  
16 property. For attending a sale of property, the sheriff may  
17 charge a fee of \$30.

18 This bill is exempt from the requirements of chapter 25B,  
19 state mandates. The increased costs required by this bill  
20 shall be paid by the political subdivisions which incurred the  
21 costs.

3 h. For the time necessarily employed in making an

5 ten dollars per hour.

6 k. For attending sale of property, ~~thirty~~ fifty dollars  
7 for personal property and one hundred dollars for real  
8 property.

9 Sec. 2. Section 25B.2, subsection 3, shall not apply to  
10 this Act.

11 EXPLANATION

12 This bill increases fees which the sheriff charges for  
13 inventorying and attending sales of property. For the  
14 inventory of personal property, the fee is increased from \$8  
15 to \$10 per hour. For attending a sale of property, the  
16 sheriff may charge a fee of \$50 for personal property and \$100  
17 for the sale of real property.

18 This bill is exempt from the requirements of chapter 25B,  
19 state mandates. The increased costs required by this bill  
20 shall be paid by the political subdivisions which incurred the  
21 costs.
