1 Section 1. NEW SECTION. 321.178A SAFE DRIVING COURSE --
2 CERTIFICATION.

3 The department shall adopt rules to establish criteria for
4 and provide for the certification of safe driving courses to
5 be offered to licensees age fifty-five and older.

6 Sec. 2. Section 321.182, Code 1997, is amended by adding
7 the following new subsection:

8 NEW SUBSECTION. 5. If the applicant is age eighty or
9 older, certify that the applicant has successfully completed a
10 safe driving course certified by the department pursuant to
11 section 321.178A.

12 Sec. 3. Section 321.196, Code 1997, is amended by adding
13 the following new unnumbered paragraph:

14 NEW UNNUMBERED PARAGRAPH. Notwithstanding this section, a
15 licensee age eighty or older, prior to each renewal of the
16 licensee's license, must successfully complete a safe driving
17 course certified by the department pursuant to section
18 321.178A.

19 Sec. 4. NEW SECTION. 516B.4 REDUCTION IN PREMIUMS FOR
20 CERTAIN INSUREDS AGE FIFTY-FIVE AND OLDER COMPLETING CERTIFIED
21 SAFE DRIVING COURSE.

22 The commissioner shall require that insurance companies
23 transacting business in this state provide an appropriate
24 reduction in premiums for automobile liability insurance for
25 an insured age fifty-five or older who successfully completes
26 a safe driving course certified by the department of
27 transportation pursuant to section 321.178A.

28 EXPLANATION

29 This bill directs the department of transportation to
30 establish criteria for, and provide for certification of,
31 driver safety courses to be offered to drivers age 55 and
32 older. A person age 80 or older is required to successfully
33 complete a certified driver safety course prior to being
34 issued a license and prior to each renewal of the licensee's
35 license. The bill directs the commissioner of insurance to

1 require insurance companies to provide a reduction in
2 automobile liability insurance premiums for licensees age 55
3 or older who successfully complete a certified safe driving
4 course.
