3 applicability date provisions.

1 Section 1. NEW SECTION. 272.9B PERMANENT SUBSTITUTE
2 TEACHER LICENSURE.

3 The board of educational examiners shall adopt rules that
4 provide for the issuance of a permanent substitute teacher
5 license to persons who retire from a school district or
6 accredited nonpublic school located in Iowa while holding a
7 valid practitioner's license.

8 Sec. 2. EMERGENCY RULES. The board of educational
9 examiners may adopt emergency rules under section 17A.4,
10 subsection 2, and section 17A.5, subsection 2, paragraph "b",
11 to implement the provisions of this Act and the rules shall be
12 effective immediately upon filing unless a later date is
13 specified in the rules. Any rules adopted in accordance with
14 this section shall also be published as a notice of intended
15 action as provided in section 17A.4.

16 Sec. 3. EFFECTIVE DATE. This Act, being deemed of
17 immediate importance, takes effect upon enactment, and applies
18 to teachers who retire as provided in section 272.9B, as
19 enacted in this Act, on or after the effective date of this
20 Act.

21 EXPLANATION

22 This bill directs the board of educational examiners to
23 adopt rules that provide for the issuance of a permanent
24 substitute teacher license for teachers who retire from a
25 school district or an accredited nonpublic school in the
26 state.

27 The bill takes effect upon enactment for teachers who
28 retire on or after the bill's effective date. The bill
29 authorizes the board to adopt emergency rules.

11 shall have until July 1, 2001, to apply to the board for a
12 permanent substitute teacher license.

13 Sec. 3. EMERGENCY RULES. The board of educational
14 examiners may adopt emergency rules under section 17A.4,
15 subsection 2, and section 17A.5, subsection 2, paragraph "b",
16 to implement the provisions of this Act and the rules shall be
17 effective immediately upon filing unless a later date is
