1 An Act relating to the regulation of certain low-speed vehicles

3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 321.1, Code Supplement 1999, is amended  
2 by adding the following new subsection after subsection 36 and  
3 renumbering subsection 36A:

4 NEW SUBSECTION. 36A. "Low-speed vehicle" means a motor  
5 vehicle manufactured in compliance with the national highway  
6 and traffic safety administration standards for low-speed  
7 vehicles in 49 C.F.R. § 571.500. A low-speed vehicle which is  
8 in compliance with the equipment requirements in 49 C.F.R. §  
9 571.500 shall be deemed to be in compliance with all equipment  
10 requirements of this chapter.

11 Sec. 2. Section 321.20, subsection 2, Code Supplement  
12 1999, is amended to read as follows:

13 2. A description of the vehicle including, insofar as the  
14 hereinafter specified data may exist with respect to a given  
15 vehicle, the make, model, type of body, the number of  
16 cylinders, the type of motor fuel used, the serial number of  
17 the vehicle, manufacturer's identification number, the engine  
18 or other number of the vehicle and whether new or used and if  
19 a new vehicle the date of sale by the manufacturer or dealer  
20 to the person intending to operate such vehicle. If the  
21 vehicle is a new low-speed vehicle, the manufacturer's or  
22 importer's certificate required to accompany the application  
23 under subsection 4 shall certify that the vehicle was  
24 manufactured in compliance with the national highway and  
25 traffic safety administration standards for low-speed vehicles  
26 in 49 C.F.R. § 571.500.

27 Sec. 3. Section 321.116, Code 1999, is amended to read as  
28 follows:

29 321.116 ELECTRIC AUTOMOBILES.

30 For an electric motor vehicle the annual fee is twenty-five  
31 dollars. However, if an electric motor vehicle is more than  
32 five model years old the annual registration fee is fifteen  
33 dollars. This section does not apply to low-speed vehicles  
34 that are electric.

35 Sec. 4. NEW SECTION. 321.381A OPERATION OF LOW-SPEED

1 VEHICLES.

2 A low-speed vehicle shall not be operated on a street with  
3 a posted speed limit greater than thirty-five miles per hour.  
4 This section shall not prohibit a low-speed vehicle from  
5 crossing a street with a posted speed limit greater than  
6 thirty-five miles per hour.

7 EXPLANATION

8 This bill defines a low-speed vehicle, for purposes of Code  
9 chapter 321, as a motor vehicle manufactured in compliance  
10 with the national highway and traffic safety administration  
11 standards for low-speed vehicles, as set forth in 49 C.F.R. §  
12 571.500. The bill deems compliance with the equipment  
13 requirements in the standards to be in compliance with the  
14 equipment requirements of Code chapter 321.

15 The bill provides that the manufacturer's or importer's  
16 certificate accompanying an application for registration and  
17 certificate of title for a new low-speed motor vehicle shall  
18 certify the vehicle was manufactured in compliance with the  
19 standards in 49 C.F.R. § 571.500.

20 The bill excludes low-speed vehicles which are electric  
21 from Code section 321.116, which provides a lower annual  
22 registration fee for electric motor vehicles than for other  
23 motor vehicles.

24 The bill also prohibits low-speed vehicles from being  
25 operated on streets with posted speed limits greater than 35  
26 miles per hour, except when crossing such a street. A  
27 violation of this prohibition is a simple misdemeanor.
