1 Section 1. Section 321.20, subsection 1, Code 1999, is
2 amended to read as follows:

3 1. The name₇; social security number or, if the owner does
4 not have a social security number but has a passport, the
5 passport number; driver's license number, whether the license
6 was issued by this state, another state, another country, or
7 is an international driver's license; date of birth₇; bona
8 fide residence; and mailing address of the owner. If the
9 owner is a firm, association, or corporation, the application
10 shall contain the business address and federal employer
11 identification number of the owner.

12 EXPLANATION

13 This bill amends Code section 321.20 to provide that an
14 owner of a motor vehicle who does not have a social security
15 number, but has a passport, shall use the owner's passport
16 number in lieu of a social security number when applying for
17 registration and issuance of a certificate of title for the
18 motor vehicle. The bill also modifies the requirement that a
19 person applying for registration and a certificate of title
20 supply the person's driver's license number to provide that
21 the driver's license number may be accepted whether the
22 license was issued in this state, another state, or another
23 country, or if the number is an international driver's license
24 number.
