2 1999, is amended to read as follows:

3 Officers and enlisted persons while in active state service  
4 shall receive the same pay, per diem, and allowances as are  
5 paid for the same rank or grade for service in the armed  
6 forces of the United States. However, a person shall not be  
7 paid at a base rate of pay of less than seventy-five one  
8 hundred dollars per calendar day of active state service.

9 EXPLANATION

10 This bill increases from \$75 to \$100 per day the minimum  
11 pay for a member of the Iowa national guard who has been  
12 called to active state service.
