1 Section 1. NEW SECTION. 56.5B LIMITATIONS ON
2 CONTRIBUTIONS.

3 1. A political committee shall not make contributions
4 that, during any election campaign cycle, in the aggregate,
5 exceed five hundred dollars to any candidate or candidate's
6 committee.

7 2. A political committee may make a contribution to a
8 candidate or candidate's committee only if the political
9 committee is organized as a political committee under section
10 56.5, and all of its officers permanently reside in Iowa.

11 3. An individual shall not make contributions that, during
12 any election campaign cycle, in the aggregate, exceed three
13 hundred dollars to any candidate or candidate's committee.

14 4. An individual shall make contributions only to a
15 candidate for whom the individual is legally entitled to vote
16 at the time the contribution is made, or to such a candidate's
17 committee.

18 5. A candidate or candidate's committee shall not
19 knowingly accept any contribution in violation of this
20 section.

21 6. For purposes of this section:

22 a. "Election campaign cycle" means the period of time
23 between any general or special election commencing on the day
24 following the previous election for that office, and
25 continuing through election day.

26 b. "Political committee" shall not include a state
27 statutory political committee, county statutory political
28 committee, city statutory political committee, or national
29 political party.

30 7. This section shall not apply to the following:

31 a. Contributions to Iowa candidates for the United States
32 senate or house of representatives, or to any other candidate
33 for federal office.

34 b. Transfers of campaign funds made pursuant to section
35 56.42.

EXPLANATION

1

2 This bill adds a new section to Code chapter 56
3 establishing certain restrictions on contributions to
4 political campaigns in Iowa.

5 Contribution limits are established for each election
6 cycle, which is defined as the period of time from a general
7 or special election, until the next election day for that
8 office. Separate limits are established for political
9 committees and individuals.

10 In addition, an individual may only make contributions to a
11 candidate for whom that individual is legally entitled to
12 vote. A political committee making a contribution to a
13 candidate or candidate's committee must be organized under
14 Code section 56.5, and all of its officers must permanently
15 reside in Iowa.

16 Statutory political committees are not subject to these
17 limitations. Contributions made or accepted in violation of
18 these provisions are punishable as serious misdemeanors under
19 Code section 56.16.
