1 An Act relating to individual and group accident and sickness
2 insurance, nonprofit health service plans, health maintenance
3 organizations, and Medicare supplemental insurance policies,
4 by mandating coverage for anesthesia and certain hospital
5 charges associated with the provision of dental care services.

- 1 Section 1. <u>NEW SECTION</u>. 514C.19 MANDATED COVERAGE FOR
- 2 DENTAL CARE -- ANESTHESIA AND CERTAIN HOSPITAL CHARGES.
- 1. Notwithstanding section 514C.6, a policy or contract
- 4 providing for third-party payment or prepayment of health or
- 5 medical expenses shall provide coverage for anesthesia and
- 6 hospital charges related to the provision of dental care
- 7 services provided to any of the following covered individuals:
- 8 a. A child under five years of age.
- 9 b. An individual who is severely disabled.
- 10 c. An individual who has a medical condition that requires
- 11 hospitalization or general anesthesia for delivery of the
- 12 dental care services.
- 13 2. A policy or contract providing for third-party payment
- 14 or prepayment of health or medical expenses shall provide
- 15 coverage for general anesthesia and treatment rendered by a
- 16 dentist for conditions covered under such policy or contract,
- 17 whether the services are provided in a hospital or a dental
- 18 office.
- 19 3. Prior authorization of hospitalization for dental care
- 20 procedures may be required in the same manner that prior
- 21 authorization is required for hospitalization for other
- 22 coverage under the contract or policy.
- 23 4. This section applies to the following contracts or
- 24 policies delivered, issued for delivery, continued, or renewed
- 25 in this state on or after July 1, 2000:
- 26 a. Individual or group accident and sickness insurance
- 27 providing coverage on an expense-incurred basis.
- 28 b. An individual or group hospital or medical service
- 29 contract issued pursuant to chapter 509, 514, or 514A.
- 30 c. An individual or group health maintenance organization
- 31 contract regulated under chapter 514B.
- d. An individual or group Medicare supplemental policy,
- 33 unless coverage pursuant to such policy is preempted by
- 34 federal law.
- 35 e. An organized delivery system licensed by the director

1 of public health. 2 **EXPLANATION** 3 This bill requires that a policy or contract providing for 4 third-party payment or prepayment of health or medical 5 expenses shall provide coverage for anesthesia and hospital 6 charges related to the provision of dental care services 7 provided to a child under five years of age; an individual who 8 is severely disabled; and an individual who has a medical 9 condition that requires hospitalization or general anesthesia 10 for the dental care services. 11 The bill requires that such policy or contract shall 12 provide coverage for general anesthesia and treatment rendered 13 by a dentist for conditions covered under such policy or 14 contract, whether the services are provided in a hospital or a 15 dental office. 16 The bill provides that prior authorization of 17 hospitalization for dental care procedures may be required in 18 the same manner that prior authorization is required for 19 hospitalization for other coverage under the contract or 20 policy. 21 22 23 24 25 26 27 28 29 30 31 32 33 34 35
