16 individual's legal guardian.

17 EXPLANATION

18 This bill authorizes disclosure of certain information to
19 the legal guardian of an individual receiving assistance or
20 services from the department of human services.

21 The bill amends Code section 217.30, relating to
22 confidentiality of the department's records. A subsection of
23 that Code section is amended to broaden an internal reference.

24 Code section 217.30 is also amended to require that any
25 confidential information relating to a particular individual
26 that is available to that individual shall be disclosed to
27 that individual's guardian.
