Section 1. Section 214A.1, Code 1999, is amended by adding 2 the following new subsections:

3 <u>NEW SUBSECTION</u>. 2A. "Motor vehicle fuel tank" means a 4 storage structure fixed to the land, including but not limited 5 to an underground storage tank subject to regulation under 6 chapter 455G or an aboveground petroleum storage tank as 7 defined in section 101.21.

EXPLANATION -

In 1999, the general assembly enacted House File 772 (1999 Rowa Acts, chapter 204), which in part provides that on or after February 1, 2000, a retail dealer of motor vehicle fuel is prohibited from offering for sale in this state fuel that contains more than 2 percent of methyl tertiary butyl ether (MTBE) by volume. The provision is uncodified.

This bill eliminates the provision in the Acts and codifies 34 similar requirements in new Code section 214A.18. The bill 35 prohibits a person from selling or storing MTBE, other than in

1 trace amounts, for use in motor vehicle fuel in this state. The bill also amends provisions which provide requirements 3 for decals identifying oxygenate enhancers, including 4 methanol. Generally, a person who violates provisions in the bill 6 would be subject to a simple misdemeanor penalty. The bill takes effect on July 1, 2001. :.

SENATE FILE 2356 FISCAL NOTE

A fiscal note for Senate File 2356 is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

BACKGROUND

Senate File 2356 amends Section 214A, subsection 16, <u>Code of Iowa</u>, Notice of Blended Fuel - Decal and prohibits the selling or storage of motor vehicle fuels containing more than a trace amount of methyl tertiary butyl ether (MTBE).

ASSUMPTIONS

- Enforcement of this Bill will require the Department of Agriculture and Land Stewardship to purchase four Zeltex ZX-440 Near-Infrared Liquid Fuel Analyzers to test for MTBE and other characteristics of fuel. The one-time cost of the fuel analyzers are \$84,000.
- 2. The Laboratory Division of the department will be required to increase the number of samples taken for analysis of MTBE levels.
- 3. Reference samples of petroleum products for calibrations of changing seasonal characteristics will be required at least four times a year.
- 4. The annual support costs of acquiring the needed number of increased petroleum samples to implement this Bill includes; \$9,000 for depreciation on the four fuel analyzers, \$20,000 for increased travel costs, \$5,000 for the increased cost of fuel for travel, and \$8,000 for outside laboratory analysis for seasonal characteristics.
- 5. The division will require \$4,000 for a computer and software for FY 2001.

FISCAL IMPACT

Senate File 2356 is expected to have an impact on the General Fund of \$128,000 in FY 2001 and \$41,000 in FY 2002.
