- 33 This bill amends Code section 321.383 to provide that a
- 34 slow-moving vehicle drawn by a horse or mule may be equipped
- 35 with an alternative reflective device that complies with rules

1 adopted by the state department of transportation if the
 2 person operating the vehicle objects for religious reasons to
3 using a reflective device that complies with the standards of
 4 the American society of agricultural engineers. Currently,
5 rules adopted by the department of transportation require that
6 a reflective device on a slow-moving vehicle comply with a
7 designated standard of the American society of agricultural
8 engineers. The standard specifies that the device be
9 triangular. Persons who violate the requirements pertaining
10 to reflective devices on slow-moving vehicles are subject to a
11 scheduled fine of $20 under Code section 805.8.

      The bill also makes a corresponding amendment to a
13 provision in Code section 321.288 which requires persons
14 operating motor vehicles to reduce their speed when
15 approaching and passing a slow-moving vehicle.

RELATING TO REFLECTIVE DEVICES ON SLOW-MOVING VEHICLES.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 321.288, subsection 5, Code 1999, is amended to read as follows:

- 5. When approaching and passing a slow moving vehicle displaying a reflective device or alternative reflective device as provided by section 321.383.
- Sec. 2. Section 321.383, subsection 2, Code 1999, is amended to read as follows:
- 2. When operated on a highway in this state at a speed of thirty miles per hour or less, every farm tractor, or tractor with towed equipment, self-propelled implement of husbandry, road construction or maintenance vehicle, road grader, horsedrawn vehicle, or any other vehicle principally designed for use off the highway and any such tractor, implement, vehicle, or grader when manufactured for sale or sold at retail after December 31, 1971, shall be identified with a reflective device in accordance with the standards of the American society of agricultural engineers; however, this provision shall not apply to such vehicles when traveling in any an escorted parade. If a person operating a vehicle drawn by a horse or mule objects to using a reflective device that complies with the standards of the American society of agricultural engineers for religious reasons, the vehicle may be identified by an alternative reflective device that is in compliance with rules adopted by the department. The reflective device or alternative reflective device shall be visible from the rear. A vehicle other than those specified in this section shall not display a reflective device or an alternative reflective device. On vehicles operating at

speeds above thirty miles per hour, the reflective device or alternative reflective device shall be removed or hidden from view.
