

1 Section 1. Section 321J.21, Code 2001, is amended to read 2 as follows:

3 321J.21 DRIVING WHILE LICENSE SUSPENDED, DENIED, REVOKED,4 OR BARRED.

5 1. A person whose driver's license or nonresident 6 operating privilege has been suspended, denied, revoked, or 7 barred due to a violation of this chapter and who drives a 8 motor vehicle <u>upon the highways of this state</u> while the 9 license or privilege is suspended, denied, revoked, or barred 10 commits a serious misdemeanor. In addition to any other 11 penalties, the punishment imposed for a violation of this 12 subsection shall include assessment of a fine of one thousand 13 dollars.

14 2. In addition to the fine, the department, upon receiving 15 the record of the conviction of a person under this section 16 upon a charge of driving a motor vehicle <u>upon the highways of</u> 17 <u>this state</u> while the license of the person was suspended, 18 denied, revoked, or barred shall extend the period of 19 suspension, denial, revocation, or bar for an additional like 20 period, and the department shall not issue a new license 21 during the additional period.

EXPLANATION

This bill provides that a person whose driver's license or nonresident operating privilege has been suspended, denied, revoked, or barred for a violation of the operating while intoxicated (OWI) provisions of the Code commits the crime of revoked, or barred only if the Code commits the crime of revoked, or barred only if the person drives a motor vehicle upon the highways of this state while the sanction is in place. Currently, Code section 321J.21 provides that a person commits such a crime if the person drives a motor vehicle anywhere while the sanction is in place. The bill aligns the OWI driving while sanctioned provisions with the driving while sanctioned provisions in Code section 321.218.
