- 1 Section 1. Section 249A.3, subsection 2, Code 2001, is
- 2 amended by adding the following new paragraph after paragraph
- 3 a, and renumbering the subsequent paragraph:
- 4 NEW PARAGRAPH. aa. As provided under the federal Breast
- 5 and Cervical Cancer Prevention and Treatment Act of 2000, Pub.
- 6 L. No. 106-354, women who meet all of the following criteria:
- 7 (1) Are not described in 42 U.S.C. § 1396a(a)(10)(A)(i).
- 8 (2) Have not attained age sixty-five.
- 9 (3) Have been screened for breast and cervical cancer
- 10 under the United States centers for disease control and
- 11 prevention breast and cervical cancer early detection program
- 12 established under 42 U.S.C. § 300k et seq., in accordance with
- 13 the requirements of 42 U.S.C. § 300n, and need treatment for
- 14 breast or cervical cancer. A woman is considered screened for
- 15 breast and cervical cancer under this subparagraph if the
- 16 woman is screened by any provider or entity, and the state
- 17 grantee of the United States centers for disease control and
- 18 prevention funds under Title XV of the federal Public Health
- 19 Services Act has elected to include screening activities by
- 20 that provider or entity as screening activities pursuant to
- 21 Title XV of the federal Public Health Services Act. This
- 22 screening includes breast or cervical cancer screenings or
- 23 diagnostic services provided by family planning or community
- 24 health centers.

- 29 EXPLANATION
- 30 This bill provides for a new category of optional coverage
- 31 under the medical assistance program. The new optional
- 32 coverage applies to certain women who require treatment for
- 33 breast or cervical cancer. Women who meet the criteria
- 34 specified in the bill are presumptively eligible for medical
- 35 assistance coverage.

# HOUSE FILE 517 FISCAL NOTE

A fiscal note for **House File 517** is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House file 517 provides for a new category of optional coverage under the medical assistance program. The new optional coverage applies to certain women who require treatment for breast or cervical cancer. Women who meet the criteria specified in the Bill are presumptively eligible for medical services.

#### ASSUMPTIONS

- Women eligible for this coverage must have been diagnosed by the Center for Disease Control's (CDC's) Breast and Cervical Cancer Early Detection Program.
- 2. The Center has projected a total of 48 women diagnosed with either breast or cervical cancer (pre-cancerous and cancerous combined).
- 3. Eligibles for this new coverage are entitled to full Medicaid coverage.
- 4. Costs for pre-cancerous eligibles are \$2,000 per case.
- 5. Costs for cancerous eligibles are \$21,000 per case.
- 6. The State would be responsible for 26.13% of the costs associate with this new coverage. The Federal share of 73.87% is the enhanced rate through September 30, 2001.
- 7. Costs for general Medicaid coverage beyond that related to cancer care included in this Bill are approximately \$3,100 per eligible.

### FISCAL IMPACT

The fiscal impact of HF 517 will result in a total cost of \$993,000 to the medical assistance program. The State portion of the cost is approximately \$260,000.

The total cost associated with the new coverage group cancer treatment is \$852,000. The State portion of the cost is approximately \$223,000.
