HOUSE FILE 560 FISCAL NOTE

A fiscal note for **House File 560** is hereby submitted pursuant to Joint Rule 17. Data used in developing this fiscal note is available from the Legislative Fiscal Bureau to members of the Legislature upon request.

House File 560 relates to child foster care regulations. The Bill requires action relating to certain health records of foster care children and clarifies that the State is responsible for the health care needs of a child when the child may be out-of-state with the foster family. The Bill also requires certain child care facilities to be eligible to serve as locations for respite care for licensed foster family homes.

ASSUMPTIONS

- 1. The Department of Human Services would seek additional health information for those children in foster care when the records may be incomplete.
- 2. The Department of Human Services would continue to provide health care for children who may be out-of-state with their foster families.
- 3. The Department of Human Services would begin to permit a registered child care home, a preschool, or a licensed child care center to provide respite care to a licensed foster family home provider. This would not increase the number of hours of respite care, but expand the number of providers available for the respite care.
- 4. The Department of Human Services may need to provide additional spot checks for inspection purposes of the child care facilities participating in the respite care provision.

FISCAL IMPACT

The estimated cost of House File 560 is expected to be minimal.

RELATING TO CHILD FOSTER CARE REGULATORY REQUIREMENTS AND PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 237.3, subsection 2, paragraph f, Code 2001, is amended to read as follows:

- f. Housing, health, safety, and medical-care policies for children receiving child foster care. The medical care policies shall include but are not limited to both of the following:
- (1) If the health records supplied in accordance with the child's case permanency plan to the foster care provider are incomplete, provision for obtaining additional health information from the child's parent or other source and supplying the additional information to the foster care provider.
- (2) Provision for emergency health coverage of the child while the child is engaged in temporary out-of-state travel with the child's foster family.
- Sec. 2. Section 237.3, Code 2001, is amended by adding the following new subsection:

NEW SUBSECTION. 10. The department shall adopt rules to administer the exception to the definition of child care in section 237A.1, subsection 3, paragraph "m", allowing a child care facility, for purposes of providing respite care to a foster family home, to provide care, supervision, or guidance of a child for a period of twenty-four hours or more who is placed with the licensed foster family home.

Sec. 3. Section 237A.1, subsection 3, Code 2001, is amended by adding the following new paragraph:

NEW PARAGRAPH. m. A child care facility providing respite care to a licensed foster family home for a period of twenty-four hours or more to a child who is placed with that licensed foster family home.
