A BILL FOR

1 An Act relating to voter registration forms, voter identification numbers, and voter registration lists. 3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 48A.11, subsection 1, paragraph e, Code 2 2001, is amended to read as follows:

e. Social security number of the registrant (optional-to
provide) and a statement informing the registrant that
disclosure of the registrant's social security number is
mandatory and that the registrant's social security number
will not be disclosed to anyone but an election official for
authorized purposes.

9 Sec. 2. <u>NEW SECTION</u>. 48A.11A REGISTRATION IDENTIFICATION 10 NUMBER.

Each person registered to vote in this state shall be assigned a registration identification number which shall be a unique identifier correlated with the registrant's social security number. The state voter registration commission shall prescribe by rule the numbering system to be used by seach county in assigning registration identification numbers. Sec. 3. Section 48A.26, subsection 2, Code 2001, is amended to read as follows:.

19 2. If the registration form appears on its face to be 20 complete and proper, the acknowledgment shall state that the 21 registrant is now a registered voter of the county. <u>The</u> 22 <u>acknowledgement shall contain the registrant's registration</u> 23 <u>identification number</u>. The acknowledgment shall also specify 24 the name of the precinct and the usual polling place for the 25 precinct in which the person is now registered. The 26 acknowledgment may include the political party affiliation 27 most recently recorded by the registrant.

28 Sec. 4. Section 48A.30, subsection 1, paragraph d, Code 29 2001, is amended to read as follows:

30 d. The clerk of the district court, or the United States 31 attorney, or the state registrar sends notice of the 32 registered voter's conviction of a felony as defined in 33 section 701.7, or conviction of an offense classified as a 34 felony under federal law. The clerk of the district court 35 shall monthly send notice a list of a felony conviction

6 Sec. 5. Section 48A.30, subsection 1, paragraph e, Code 7 2001, is amended to read as follows:

8 e. The clerk of the district court or the state registrar 9 sends notice that the registered voter has been declared a 10 person who is mentally incompetent to vote under state law. 11 <u>The clerk of the district court shall monthly send a list of</u> 12 <u>such declarations adjudicated in the previous calendar month</u> 13 <u>to the state registrar of voters. The registrar shall</u> 14 <u>determine in which county the person is registered to vote, if</u> 15 <u>any, and shall notify the county commissioner of registration</u> 16 <u>for that county of the declaration.</u>

17 Sec. 6. Section 48A.31, Code 2001, is amended to read as 18 follows:

19 48A.31 DECEASED PERSONS RECORD.

The state registrar of vital statistics shall transmit or 20 21 cause to be transmitted to the state registrar of voters, once 22 each calendar-quarter month, a certified list of all persons 23 seventeen and one-half years of age and older in the state 24 whose deaths have been reported to the records and statistics 25 division of the Iowa department of public health since the 26 previous list of decedents was certified to the state 27 registrar of voters. The list shall be submitted according to 28 the specifications of the state registrar of voters, who shall 29 determine whether each listed decedent was registered to vote 30 in this state. If the decedent was registered in a county 31 which uses its own data processing facilities for voter 32 registration recordkeeping, the registrar shall notify the 33 commissioner in that county who shall cancel the decedent's 34 registration. If the decedent was registered in a county for 35 which voter registration recordkeeping is performed under

5 Sec. 7. Section 48A.34, Code 2001, is amended to read as 6 follows:

7 48A.34 CONFIDENTIALITY OF CERTAIN RECORDS.

8 Voter registration records are available for public 9 inspection at reasonable times at the office of the county 10 commissioner. The commissioner and any voter registration 11 agency which has custody of voter registration records shall 12 take the necessary steps to ensure that the <u>social security</u> 13 <u>number of the registrant and the</u> name of the agency at which 14 the voter registration form was submitted remains 15 confidential.

16 Sec. 8. Section 48A.38, subsection 1, paragraph a, Code 17 2001, is amended to read as follows:

a. The registrar shall prepare each list requested within
fourteen days of receipt of the request, except that the
registrar shall not be required to prepare any list within
seven six days of the close-of-registration election for any
regularly scheduled election if the preparation of the list
would impede the preparation of election registers for that
election. On the seventh day before each regularly scheduled
election, the state registrar of voters shall make available
for public inspection the most recently updated list of
registered voters. The list shall contain the name, address,
and registration identification number of each registrant in
the state.

30 Sec. 9. Section 48A.38, subsection 1, paragraph b, Code 31 2001, is amended to read as follows:

32 b. Each list shall be as current as possible, but shall in 33 all cases reflect voter activity reported to any commissioner 34 twenty-eight-or-more at least seven days before preparation of 35 the list.

Sec. 10. Section 48A.38, subsection 1, Code 2001, is
 amended by adding the following new paragraph:

3 <u>NEW PARAGRAPH</u>. f. The county commissioner of registration 4 and the state registrar of voters shall remove a voter's 5 social security number from a voter registration list prepared 6 pursuant to this section. However, the list may contain the 7 registration identification number assigned to a voter, if 8 requested.

EXPLANATION

10 This bill makes a number of changes to the voter 11 registration law.

9

12 The bill requires that each person registering to vote 13 supply their social security number on the registration form. 14 The form is to include a statement informing the registrant 15 that the registrant's social security number will not be 16 disclosed except to election officials for authorized 17 purposes. The bill requires that a registration 18 identification number be assigned to each registrant. The 19 identification number is to correlate with the registrant's 20 social security number. The bill requires the state voter 21 registration system to prescribe by rule the numbering system 22 to be used by counties in assigning registration 23 identification numbers.

The bill repeats in the voter registration Code chapter the requirement found elsewhere in the Code that the clerk of district court monthly send a list of the persons convicted of referring calendar month. The bill also changes the time period in which the state registrar of vital statistics is required to send a list of deceased persons to the state registrar of voters from each calendar quarter to monthly. The bill provides that the state registrar of voters shall not be required to prepare a requested list of registered voters within six days of any regularly scheduled election, rather than within seven days of the close of registration.

1 Each list prepared by the registrar is required to reflect 2 voter activity at least seven days before preparation of the 3 list, rather than 28 days before preparation of the list. The 4 bill requires the state registrar of voters, on the seventh 5 day before each regularly scheduled election to make an 6 updated list of registered voters available for public 7 inspection. The list is required to contain the name, 8 address, and registration identification number of each 9 registrant. Finally, the bill provides that the county commissioner of 10 11 elections and voter registration agencies are to ensure that 12 social security numbers of registrants are to remain 13 confidential. Any list prepared for persons other than 14 election officials for authorized purposes shall not contain 15 the social security number of the registrant, but may contain 16 the registration identification number assigned the voter. 17 18 19 20 21 22 23 24 25 26 27 28 29 30 31 32 33 34 35



The list shall contain the name, address,</u> and registration identification number of each registrant in <u>the state.</u>

30 Sec. 9. Section 48A.38, subsection 1, paragraph b, Code 31 2001, is amended to read as follows:

32 b. Each list shall be as current as possible, but shall in 33 all cases reflect voter activity reported to any commissioner 34 twenty-eight-or-more at least seven days before preparation of 35 the list.

1 Sec. 10. Section 48A.38, subsection 1, Code 2001, is 2 amended by adding the following new paragraph:

3 <u>NEW PARAGRAPH</u>. f. The county commissioner of registration 4 and the state registrar of voters shall remove a voter's 5 social security number from a voter registration list prepared 6 pursuant to this section. However, the list may contain the 7 registration identification number assigned to a voter, if 8 requested.

EXPLANATION

10 This bill makes a number of changes to the voter 11 registration law.

9

12 The bill requires that each person registering to vote 13 supply their social security number on the registration form. 14 The form is to include a statement informing the registrant 15 that the registrant's social security number will not be 16 disclosed except to election officials for authorized 17 purposes. The bill requires that a registration 18 identification number be assigned to each registrant. The 19 identification number is to correlate with the registrant's 20 social security number. The bill requires the state voter 21 registration system to prescribe by rule the numbering system 22 to be used by counties in assigning registration 23 identification numbers.

The bill repeats in the voter registration Code chapter the requirement found elsewhere in the Code that the clerk of district court monthly send a list of the persons convicted of r a felony or declared mentally incompetent to vote in the preceding calendar month. The bill also changes the time period in which the state registrar of vital statistics is required to send a list of deceased persons to the state registrar of voters from each calendar quarter to monthly. The bill provides that the state registrar of voters shall not be required to prepare a requested list of registered voters within six days of any regularly scheduled election, frather than within seven days of the close of registration.

1 Each list prepared by the registrar is required to reflect 2 voter activity at least seven days before preparation of the 3 list, rather than 28 days before preparation of the list. The 4 bill requires the state registrar of voters, on the seventh 5 day before each regularly scheduled election to make an 6 updated list of registered voters available for public 7 inspection. The list is required to contain the name, 8 address, and registration identification number of each 9 registrant.

10 Finally, the bill provides that the county commissioner of 11 elections and voter registration agencies are to ensure that 12 social security numbers of registrants are to remain 13 confidential. Any list prepared for persons other than 14 election officials for authorized purposes shall not contain 15 the social security number of the registrant, but may contain 16 the registration identification number assigned the voter. 17
