4 A Resolution honoring Iowa's collegiate athletes,
5 coaches, and coaching staff.

6 WHEREAS, the Iowa State Cyclones men's basketball
7 team compiled a record of 25 wins and five losses this
8 season to become the number 2 seed in the west
9 regional NCAA Men's Basketball Tournament under the
10 tutelage of the coaching staff and Coach Larry
11 Eustachy; and

12 WHEREAS, the Iowa State Cyclones women's basketball
13 team compiled a record of 25 wins and five losses to
14 earn the number 2 seed in the midwest region of the
15 NCAA Women's Basketball Tournament, with the guidance
16 of the coaching staff and Coach Bill Fennelly; and

17 WHEREAS, the University of Iowa Hawkeyes men's
18 basketball team had a season record of 22 wins and 11
19 losses, earned a number 7 seed, and won the regular
20 season Big 12 title, moving into the east region of
21 the NCAA Men's Basketball Tournament, with the
22 leadership of Coach Steve Alford and the coaching
23 staff; and

24 WHEREAS, the University of Iowa Hawkeyes women's
25 basketball team compiled a season record of 20 wins
26 and nine losses, won the Big Ten Conference, earning a
27 number 4 seed in the midwest region NCAA Women's
28 Basketball Tournament, under the direction of the
29 coaching staff and Coach Lisa Bluder; and

30 WHEREAS, the Drake Bulldogs women's basketball team
