- 1 Section 1. NEW SECTION. 717E.1 DEFINITIONS.
- 2 As used in this chapter, unless the context otherwise
- 3 requires:
- 4 l. "Advertise" means to present a commercial message in
- 5 any medium including but not limited to print, radio,
- 6 television, sign, display, label, tag, or articulation.
- 7 2. "Business" means any enterprise relating to any of the 8 following:
- 9 a. The sale or offer for sale of goods or services.
- 10 b. A recruitment for employment or membership in an
- 11 organization.
- 12 c. A solicitation to make an investment.
- d. An amusement or entertainment activity.
- 14 3. "Fair" means any of the following:
- 15 a. The annual fair and exposition held by the Iowa state
- 16 fair board pursuant to chapter 173 or any fair held by a
- 17 county or district fair or agricultural society under the
- 18 provisions of chapter 174.
- 19 b. An exhibition of agricultural or manufactured products.
- 20 c. An event for operation of amusement rides or devices or
- 21 concession booths.
- 22 4. "Game" means a "game of chance", "game of skill", or
- 23 "raffle" as defined in section 99B.1.
- 24 5. "Pet" means a living animal which is limited to a dog,
- 25 cat, or an animal normally maintained in a small tank or cage
- 26 in or near a residence, including but not limited to a rabbit,
- 27 gerbil, hamster, mouse, parrot, canary, mynah, finch, tropical
- 28 fish, goldfish, snake, turtle, gecko, or iguana.
- 29 Sec. 2. NEW SECTION. 717E.2 PET AWARDS PROHIBITED.
- 30 A person is guilty of a serious misdemeanor if the person
- 31 awards a pet or advertises that a pet may be awarded as any of
- 32 the following:
- 33 1. A prize for participating in a game.
- 34 2. A prize for participating in a fair event.
- 35 3. An inducement or condition for visiting a place of

- 1 business or attending an event sponsored by a business.
- 2 4. An inducement or condition for executing a contract
- 3 which includes provisions unrelated to the ownership, care, or
- 4 disposition of the pet.
- 5 Sec. 3. NEW SECTION. 717E.3 EXCEPTION -- LICENSED PET
- 6 SHOPS.
- 7 This chapter shall not apply to a pet shop licensed
- 8 pursuant to section 162.5 if the award of a pet is provided in
- 9 connection with a sale of a pet on the premises of the pet
- 10 shop.
- 11 EXPLANATION
- 12 This bill creates a new Code chapter 717E in proximity to
- 13 other criminal chapters providing for animal welfare. The
- 14 bill provides that a person is guilty of a serious misdemeanor
- 15 if the person awards a pet or advertises that a pet may be
- 16 awarded as a prize for participating in a game or fair event,
- 17 an inducement or condition for visiting a place of business or
- 18 attending a business event, or an inducement or benefit for
- 19 executing a contract. The bill does not apply to awards of
- 20 pets in connection with sales of pets by licensed pet shops.
- 21 A serious misdemeanor is punishable by confinement for no more
- 22 than one year and a fine of at least \$250 but not more than
- 23 \$1,500.
