A BILL FOR

1 An Act relating to motor vehicle registration fees for
2 multipurpose vehicles and providing an effective date.
3 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

1 Section 1. Section 321.109, subsection 1, Code 2003, is
2 amended to read as follows:

3 1. a. The annual fee for all motor vehicles, including
4 multipurpose vehicles and vehicles designated by manufacturers
5 as station wagons, ~~and-1993-and-subsequent-model-years-for~~
6 ~~multipurpose-vehicles,~~ except motor trucks, motor homes,
7 ambulances, hearses, motorcycles, and motor bicycles, ~~and-1992~~
8 ~~and-older-model-years-for-multipurpose-vehicles,~~ shall be
9 equal to one percent of the value as fixed by the department
10 plus forty cents for each one hundred pounds or fraction
11 thereof of weight of vehicle, as fixed by the department. The
12 weight of a motor vehicle, fixed by the department for
13 registration purposes, shall include the weight of a battery,
14 heater, bumpers, spare tire, and wheel. Provided, however,
15 that for any new vehicle purchased in this state by a
16 nonresident for removal to the nonresident's state of
17 residence the purchaser may make application to the county
18 treasurer in the county of purchase for a transit plate for
19 which a fee of ten dollars shall be paid. And provided,
20 however, that for any used vehicle held by a registered dealer
21 and not currently registered in this state, or for any vehicle
22 held by an individual and currently registered in this state,
23 when purchased in this state by a nonresident for removal to
24 the nonresident's state of residence, the purchaser may make
25 application to the county treasurer in the county of purchase
26 for a transit plate for which a fee of three dollars shall be
27 paid. The county treasurer shall issue a nontransferable
28 certificate of registration for which no refund shall be
29 allowed; and the transit plates shall be void thirty days
30 after issuance. Such purchaser may apply for a certificate of
31 title by surrendering the manufacturer's or importer's
32 certificate or certificate of title, duly assigned as provided
33 in this chapter. In this event, the treasurer in the county
34 of purchase shall, when satisfied with the genuineness and
35 regularity of the application, and upon payment of a fee of

1 ten dollars, issue a certificate of title in the name and
2 address of the nonresident purchaser delivering the same to
3 the person entitled to the title as provided in this chapter.
4 ~~The provisions of this subsection relating to multipurpose~~
5 ~~vehicles are effective January 1, 1993, for all 1993 and~~
6 ~~subsequent model years. The annual registration fee for~~
7 ~~multipurpose vehicles that are 1992 model years and older~~
8 ~~shall be in accordance with section 321.124.~~

9 b. The Notwithstanding paragraph "a", the annual
10 registration fee for a multipurpose vehicle with permanently
11 installed equipment manufactured for and necessary to assist a
12 person with a disability who is either the owner or a member
13 of the owner's household in entry and exit of the vehicle or
14 for a multipurpose vehicle if the vehicle's owner or a member
15 of the vehicle owner's household uses a wheelchair as the only
16 means of mobility shall be sixty dollars. For purposes of
17 this unnumbered paragraph, "uses a wheelchair" does not
18 include use of a wheelchair due to a temporary injury or
19 medical condition.

20 Sec. 2. Section 321.113, subsection 5, paragraph a, Code
21 2003, is amended to read as follows:

22 a. If a 1993 model year or older motor vehicle, other than
23 a multipurpose vehicle, has been titled in the same person's
24 name since the vehicle was new or the title to the vehicle was
25 transferred prior to January 1, 2002, the part of the
26 registration fee that is based on the value of the vehicle
27 shall be ten percent of the rate as fixed when the motor
28 vehicle was new.

29 Sec. 3. Section 321.113, subsection 5, paragraph b,
30 unnumbered paragraph 1, Code 2003, is amended to read as
31 follows:

32 If the title of a 1993 model year or older motor vehicle is
33 transferred to a new owner or if such a motor vehicle is
34 brought into the state on or after January 1, 2002, or if a
35 vehicle is a 1993 model year or older multipurpose vehicle,

1 the registration fee shall not be based on the weight and list
2 price of the motor vehicle, but shall be as follows:

3 Sec. 4. Section 321.113, subsection 5, paragraph b, Code
4 2003, is amended by adding the following new unnumbered
5 paragraph:

6 NEW UNNUMBERED PARAGRAPH. Notwithstanding subsection 1,
7 the reduced fees in this paragraph "b" apply to all 1993 model
8 year or older multipurpose vehicles, including multipurpose
9 vehicles described in section 321.109, subsection 1, paragraph
10 "b".

11 Sec. 5. Section 321.124, subsection 3, unnumbered
12 paragraph 1, Code 2003, is amended to read as follows:

13 The annual registration fee for motor homes ~~and 1992 and~~
14 ~~older model years for multipurpose vehicles~~ is as follows:

15 Sec. 6. Section 321.124, subsection 3, paragraph h, Code
16 2003, is amended by striking the paragraph.

17 Sec. 7. Section 422.9, subsection 2, paragraph h, Code
18 Supplement 2003, is amended to read as follows:

19 h. To the extent not otherwise included pursuant to
20 section 164 of the Internal Revenue Code, add the amount of
21 the annual registration fee paid for a multipurpose vehicle
22 pursuant to section ~~321.124, subsection 3, paragraph "h"~~
23 321.113, subsection 5, paragraph "b", which is based upon the
24 value of the vehicle. For purposes of this paragraph, sixty
25 percent of the amount of the registration fee is based upon
26 the value of the multipurpose vehicle.

27 Sec. 8. Section 422.35, subsection 15, Code Supplement
28 2003, is amended to read as follows:

29 15. To the extent not otherwise included pursuant to
30 section 164 of the Internal Revenue Code, subtract the amount
31 of the annual registration fee paid for a multipurpose vehicle
32 pursuant to section ~~321.124, subsection 3, paragraph "h"~~
33 321.113, subsection 5, paragraph "b", which is based upon the
34 value of the vehicle. For purposes of this subsection, sixty
35 percent of the amount of the registration fee is based upon
