Section 1. Section 321M.9, subsection 1, Code Supplement
2 2003, is amended to read as follows:

1. FEES TO COUNTIES. Notwithstanding any other provision 3 4 in the Code to the contrary, the county treasurer of any 5 county authorized to issue driver's licenses under this 6 chapter shall retain for deposit in the county general fund 7 five seven dollars of fees received for each issuance or 8 renewal of driver's licenses and nonoperator identification 9 cards, but shall not retain any moneys for the issuance of any 10 persons with disabilities identification devices. The county 11 treasurer shall remit the balance of fees to the department. 12 Sec. 2. 2003 Iowa Acts, chapter 8, section 27, is 13 repealed.

EXPLANATION

This bill increases the amount of the fee retained by a county treasurer for the issuance or renewal of driver's licenses and nonoperator identification cards from \$5 to \$7 per transaction. A temporary increase in the fee amount from \$3.75 to \$5 was effective on July 1, 2003, and due to expire on July 1, 2005. The bill repeals that expiration provision. 1 22 23
