Section 1. Section 99B.7, subsection 1, paragraph c, 2 unnumbered paragraph 1, Code Supplement 2003, is amended to 3 read as follows: Cash or merchandise prizes may be awarded in the game of 5 bingo and, except as otherwise provided in this paragraph, 6 shall not exceed one hundred dollars. Merchandise prizes may 7 be awarded in the game of bingo, but the actual retail value 8 of the prize, or if the prize consists of more than one item, 9 unit or part, the aggregate retail value of all items, units 10 or parts, shall not exceed the maximum provided by this 11 paragraph. A jackpot bingo game may be conducted once twice 12 during any twenty-four-hour twenty-four-hour period in which 13 the prize may begin at not more than three five hundred 14 dollars in cash or actual retail value of merchandise prizes 15 and may be increased by not more than one hundred dollars in 16 cash or actual retail value of merchandise prizes after each 17 bingo occasion to a maximum prize of one thousand dollars in 18 cash or actual retail value of merchandise prizes for the 19 first jackpot bingo game and two thousand five hundred dollars 20 in cash or actual retail value of merchandise prizes for the 21 second jackpot bingo game. However, the cost of play in a 22 jackpot bingo game shall not be increased and-the-jackpot 23 shall-not-amount-to-more-than-eight-hundred-dollars-in-cash-or 24 actual-retail-value-of-merchandise-prizes. A jackpot bingo 25 game is not prohibited by paragraph "h". A bingo occasion 26 shall not last for longer than four consecutive hours. 27 qualified organization shall not hold more than fourteen bingo 28 occasions per month. Bingo occasions held under a limited 29 license shall not be counted in determining whether a 30 qualified organization has conducted more than fourteen bingo 31 occasions per month, nor shall bingo occasions held under a 32 limited license be limited to four consecutive hours. 33 the exception of a limited license bingo, no more than three 34 bingo occasions per week shall be held within a structure or 35 building and only one person licensed to conduct games under

      This bill deals with allowable jackpots for bingo games.
 6 Code section 99B.7, subsection 1, is amended to permit two
 7 jackpot bingo games during a 24-hour period and to authorize a
 8 maximum prize of $1,000 for the first jackpot bingo game and
 9 $2,500 for the second jackpot bingo game. In addition, the
10 bill provides that the starting jackpot for a bingo game shall
11 not exceed $500. Under current law, only one jackpot bingo
12 game is authorized with a maximum prize of $800 and a starting
13 jackpot of no more than $300.
