- 1 Section 1. NEW SECTION. 331.309 CONFINEMENT FEEDING
- 2 OPERATIONS -- SITING ORDINANCE.
- 3 1. As used in this section:
- 4 a. "Animal feeding operation structure" means the same as
- 5 defined in section 459.102.
- 6 b. "Animal unit capacity" means the same as defined in
- 7 section 459.102.
- 8 c. "Confinement feeding operation" means the same as
- 9 defined in section 459.102.
- 10 2. a. Notwithstanding sections 331.304A and 335.2, a
- 11 county may adopt a confinement feeding operations siting
- 12 ordinance pursuant to section 331.302. The purpose of the
- 13 ordinance shall be to allow approval of the siting of a
- 14 confinement feeding operation regardless of whether the county
- 15 has adopted an ordinance under chapter 335.
- 16 b. The confinement feeding operation siting ordinance
- 17 shall apply to the siting of animal feeding operation
- 18 structures which are part of confinement feeding operations in
- 19 which swine are kept. However, the ordinance shall not apply
- 20 to a confinement feeding operation having an animal unit
- 21 capacity of swine of seven hundred or fewer animal units.
- 22 c. The ordinance shall authorize a county to approve the
- 23 site of the construction or expansion of a confinement feeding
- 24 operation, including confinement feeding operation buildings
- 25 and related animal feeding operation structures in order to
- 26 preserve and protect natural resources, including water
- 27 sources and fragile environmental locations; lessen congestion
- 28 and overcrowding of confinement feeding operations, especially
- 29 near cities; and to protect the health and welfare of the
- 30 public.
- 31 d. The ordinance shall provide for methods and procedures
- 32 required for submission of proposals, review of proposals, and
- 33 approval of a site. In administering the ordinance, the
- 34 county shall establish a confinement feeding operations siting
- 35 commission which shall review each proposal for the

1 construction or expansion of a confinement feeding operation,
 2 and recommend to the county board of supervisors that the
 3 board approve or disapprove the proposal.
                                              The board shall
 4 appoint five persons as members of the commission.
 5 members shall not reside in a city, and one member shall
6 reside in a city. At least three of the members shall be
7 persons who are or were actively engaged in animal
8 agriculture. The commission shall make its recommendation to
9 the board within forty-five days after the date that the board
10 receives a complete proposal. The board shall approve or
11 disapprove a proposal within forty-five days after the date
12 that the board receives the commission's recommendation
13 regarding approval or disapproval.

15 2003, is amended to read as follows:
         The department shall issue a construction permit upon
17 approval of an application. The department shall approve the
18 application if the application is submitted to the county
19 board of supervisors in the county where the proposed
20 confinement feeding operation structure is to be located as
21 required pursuant to section 459.304, and the application
22 meets the requirements of this chapter, and the construction
23 complies with a confinement feeding operations siting
24 ordinance if adopted by a county as provided in section
25 331.309. If a county submits an approved recommendation
26 pursuant to a construction evaluation resolution filed with
27 the department, the application must also achieve a
28 satisfactory rating produced by the master matrix used by the
29 board or department under section 459.304. The department
30 shall approve the application regardless of whether the
31 applicant is required to be issued a construction permit.

                             EXPLANATION
     This bill enacts or amends several provisions relating to
33
34 confinement feeding operations regulated by the department of
```

35 natural resources. A confinement feeding operation is a type

1 of animal feeding operation in which animals are kept in areas 2 which are totally roofed. The bill creates new Code section 3 331.309, which provides that a county may adopt a siting 4 ordinance for confinement feeding operations in which swine 5 are kept. The bill provides that the ordinance must provide 6 for methods and procedures required for review and approval of 7 site proposals. As part of this process, the county must 8 establish a confinement feeding operations siting commission 9 to review proposals for the construction or expansion of a 10 confinement feeding operation. The bill also amends Code section 459.303, which requires 12 the department to issue permits for the construction of 13 confinement feeding operation structures. These structures 14 include confinement buildings and manure storage facilities. 15 The bill provides that the department may issue a permit if 16 the construction complies with a confinement feeding 17 operations siting ordinance adopted by a county pursuant to 18 the bill. 19 The bill provides that a county's siting ordinance does not 20 apply to a confinement feeding operation having an animal unit 21 capacity of 700 or fewer animal units. 22 Pursuant to Code section 459.603, a person who constructs 23 an animal feeding operation without a permit is subject to a 24 civil penalty of \$5,000 for each day of the violation. 25 26 27 28 29 30 31 32 33 34
