- 22 on active duty in the Vietnam service area, within the dates
- 23 specified, not to exceed a total sum of \$500. Persons who
- 24 served on active duty during the specified period but not in
- 25 the Vietnam service area may receive \$12.50 per month, not to
- 26 exceed \$300. The bonus payments are exempt from taxation,
- 27 levy, and execution. A criminal penalty is provided for a
- 28 submission of a fraudulent application for the bonus.
