1 Section 1. Section 483A.20, Code Supplement 2003, is
2 amended to read as follows:

3 483A.20 RECIPROCITY.

4 Licenses for bait dealers or for fishing, hunting, or fur
5 harvesting shall not be issued to residents of states that do
6 not sell similar licenses or certificates to residents of
7 Iowa. However, this requirement is not applicable to the
8 licensing of nonresident wholesale bait dealers who sell to
9 licensed wholesale bait dealers in Iowa for resale.

10 EXPLANATION

11 This bill provides that nonresident wholesale bait dealers
12 who sell to licensed wholesale bait dealers in Iowa for resale
13 may be licensed in Iowa whether or not the nonresident
14 wholesale bait dealer's state sells similar licenses or
15 certificates to residents of Iowa.

AN ACT

RELATING TO LICENSING OF NONRESIDENT BAIT DEALERS AND
PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 483A.20, Code Supplement 2003, is amended to read as follows:

483A.20 RECIPROCITY.

Licenses for bait dealers or for fishing, hunting, or fur harvesting shall not be issued to residents of states that do not sell similar licenses or certificates to residents of Iowa. However, this requirement is not applicable to the licensing of nonresident wholesale bait dealers who sell to licensed wholesale bait dealers in Iowa for resale.
