- 3 1. Make-all Adopt any necessary rules rule for the
- 4 suppression-and-prevention control of an infectious and or
- 5 contagious diseases-among disease affecting animals within the 6 state.
- 7 2. Provide for quarantining animals affected afflicted
- 8 with an infectious or contagious diseases disease, or that
- 9 have been exposed to such diseases disease, whether within or
- 10 without the state.
- 11 3. Determine and employ the most efficient and practical
- 12 means for the prevention, -suppression, -control, -and
- 13 eradication control of contagious-or an infectious diseases
- 14 among or contagious disease afflicting animals.
- 15 4. Establish, maintain, enforce, and regulate quarantine
- 16 and other measures relating to the movements movement and care
- 17 of diseased animals that may be exposed or afflicted with an
- 18 infectious or contagious disease.
- 19 5. Provide for the disinfection of suspected yards,
- 20 buildings, and or articles, and for the destruction of such
- 21 animals as may be deemed necessary by the department.
- 22 6. Enter any place where any animal is at the time
- 23 located, or where it has been kept, or where the carcass of
- 24 such animal may be, for the purpose of examining it in any way
- 25 that may be necessary to determine whether it was or is
- 26 infected exposed to or afflicted with any an infectious or
- 27 contagious or-infectious disease.
- 28 7. Regulate or prohibit the arrival in, departure from,
- 29 and passage through the state, of animals infected exposed to
- 30 or afflicted with or-exposed-to-any an infectious or
- 31 contagious disease; and in case of a violation of any such
- 32 regulation or prohibition, to detain any animal at the owner's
- 33 cost expense.

- 31 EXPLANATION
- 32 This bill amends a number of provisions in Title V of the
- 33 Code relating to animal health, and specifically infectious or
- 34 contagious diseases regulated by the department of agriculture
- 35 and land stewardship. The bill amends the term "infectious or

1 contagious" throughout the title to be consistent.
2 provides a common definition of the term "certificate of
3 veterinary inspection" (formerly "health certificate" or
 4 "certificate of health") as used throughout chapters
5 regulating animal health. The definition is borrowed from
6 Code chapter 163A regulating brucellosis in swine.
7 also amends Code chapter 163 to provide a definition of
8 "control" and "movement".
     Code section 163.1 currently authorizes the department to
10 quarantine animals that have been infected or exposed to an
11 infectious or contagious disease and provides for the
12 destruction of such animals as determined by the department.
13 This presumably refers to animals which have been exposed to
14 or afflicted with the disease and this bill specifically
15 provides for that. The bill makes a related change to Code
16 section 163.10, which provides for quarantining and destroying
17 animals infected with the disease. The bill provides that
18 this includes animals which are exposed to the disease. Code
19 section 163.15 currently provides for indemnifying owners
20 whose livestock has been destroyed by the department. One
21 method is based on a formula adopted by the department and
22 approved by the executive council. The other method is an
23 appraisal method. The bill provides an appropriation to the
24 department from the general fund as approved by the executive
25 council to support payments under the formula method just as
26 executive council approves payments now based on the appraisal
27 method.
