- 1 Section 1. Section 49.13, Code 2003, is amended by adding
- 2 the following new subsection:
- NEW SUBSECTION. 5. The commissioner may appoint high
- 4 school students who are not yet qualified to be registered
- 5 voters to serve as precinct election board members.
- 6 a. To qualify to serve as a precinct election board
- 7 member, a high school student shall:
- 8 (1) Be a United States citizen.
- 9 (2) Be a junior or senior in good standing enrolled in a
- 10 public or private secondary school in Iowa.
- 11 (3) Have a cumulative grade point average equivalent to at
- 12 least 2.0 on a 4.0 scale.
- 13 (4) At the time of appointment, have the written approval
- 14 of the principal of the secondary school the student attends.
- 15 (5) Have the written approval of the student's parent or
- 16 legal guardian.
- 17 (6) Have satisfactorily completed the training course for
- 18 election officials.
- 19 (7) Meet all other qualifications for appointment and
- 20 service as an election board member except the requirement of
- 21 being a registered voter.
- 22 b. No more than one student precinct election board member
- 23 may serve on each precinct election board.
- 24 c. Student precinct election board members shall not serve
- 25 as the chairperson of a precinct election board.
- 26 d. Before serving at a partisan election, the student
- 27 election precinct board member must certify in writing to the
- 28 commissioner the political party with which the student is
- 29 affiliated.
- 30 e. Student precinct election board members shall not be
- 31 counted as absent from school on the day they serve as
- 32 election officials.
- 33 f. Student precinct election board members shall not be
- 34 allowed to work more hours than allowed under the applicable
- 35 labor laws.

 9 high school juniors and seniors who are not yet qualified to
10 be registered voters to be appointed as precinct election
11 board members, but not board chairpersons, if they meet
12 certain statutory requirements.
